#### Board Meeting Minutes July 24, 2024

A regular meeting of the New Brunswick Parking Authority was held on July 24, 2024, in the conference room of the New Brunswick Parking Authority, located at 106 Somerset Street, New Brunswick, New Jersey. General Counsel Aaron Rainone called the meeting to order at 5:00 p.m.

#### Minutes

On motion of Mr. Zimmerman, seconded by Mr. Sleiman, the board approved the minutes from the April 2024 special board meeting. Vote: 3 - yes, 0 - no, 1 - abstain, 1- absent.

On motion of Ms. Soto, seconded by Mr. McTernan, the board approved the minutes from the May 2024 regular board meeting. Vote: 4 - yes, 0 - no, 0- abstain, 1- absent.

### **Executive Director's Report**

Mr. Karon reported that the TIBA PARCS installation at the Wellness Garage has been completed. Users have expressed satisfaction with the new validation system, noting that it is more user-friendly. Additionally, there are fewer issues at the exit gates, leading to a reduction in traffic delays.

Mr. Karon reported on the restorations and maintenance of the facilities, noting that work is ongoing. The Paterson Garage is approximately 90%-95% complete, while the Church Street Garage is about 85-90% complete and is expected to be finished by August 1st. The contractor will begin mobilizing at Civic on July 30th, and work at the Morris Street Garage is still pending.

Mr. Karon reported on the proposed resolution to approve an increase in the hourly rate at the NBPA facilities. Operating expenses have been rising consistently due to inflation and the aging mechanical equipment within the garages, particularly the elevators and fire sprinkler systems, which are beginning to malfunction. Additionally, the cost of hiring qualified personnel has increased significantly over the past few years. Given these circumstances, today's agenda includes a resolution requesting the commissioners to approve an increase in the hourly rate: \$1.00 at our gated parking facilities, \$0.50 at the NBPAC Garage, and \$0.50 at the Liberty and City Hall lots. This increase would take effect on September 1st. The last rate increase at our garages was implemented over seven years ago, on January 1, 2017.

This adjustment will help cover rising operating costs and improve our competitiveness when hiring new employees.

Mr. Karon reported that Lieutenant Antoine Johnson will be retiring effective August 1, 2024. Antoine has been an integral part of the authority's management team, having served for 27 years. Mr. Karon asked the commissioners to join in expressing their gratitude to Lieutenant Johnson for his dedicated years of service and in wishing him all the best on his retirement as well.

#### **Finance**

Mr. Rajaratnam reported that the annual audit has not yet been completed and is expected to be finalized by August. Still waiting for information provided by the State.

#### Legal

#### **Public Comment**

A member of the public asked about any update on the search for a permanent Director for the NBPA. Mr. McTernan stated that Mr. Karon has done an excellent job in his current role. Discussions are underway regarding the next steps, and over the coming year, there will be a focus on identifying and bringing in the right talent for the position.

A member of the public inquired about the plans discussed at the Robert Wood Johnson Hospital Board meeting regarding collaboration with the New Brunswick Parking Authority on a new parking structure. Mr. McTernan stated that there are currently no specific plans in place. However, substantial data collection is being conducted by the hospital's team who run those projects.

A member of the public asked if there is any update on the Supermarket space. Mr. Karon stated they are collaborating with a potential tenant.

A member of the public asked about the total debt. Mr. Rajaratnam stated it is still the same amount of, \$194,000,000.

A member of the public asked if there is any update on arrangements for zoom meetings for the board meetings going forward. Mr. McTernan stated he has not thought about it since the recommendation last meeting, no decisions have been made yet regarding this.
