Board Meeting Minutes July 23, 2025

A regular meeting of the New Brunswick Parking Authority was held on July 23, 2025, in the conference room of the New Brunswick Parking Authority, located at 106 Somerset Street, New Brunswick, New Jersey. General Counsel Aaron Rainone called the meeting to order at 5:00 p.m.

General Counsel Aaron Rainone read the public statement as required by P. L. 1975.

Executive Director's Report

Mr. Karon reported on the 2025 restoration project, stating that the Gateway work is approximately 95% complete. The only remaining items are the traffic coating at the first and last turns of the garage. The Wellness portion of the project is approximately 70% complete.

Mr. Karon reported on the EV charging stations, stating that the Authority will be issuing a bid to hire a vendor who will install, operate, and maintain the stations, as well as manage rate-setting and payment options. The arrangement will include a revenue-sharing agreement, which is expected to be more advantageous to the Authority compared to the NBPA owning and being solely responsible for maintenance and electricity costs. The bid is expected to be posted at the beginning of August, with the goal of having a vendor approved at the September board meeting.

Mr. Karon reported on the LCSD project, noting that the installation of the new PARCS system has been completed at the Church Street Garage. The next garage scheduled for conversion is the Plum Street Garage, with installation expected to begin sometime in August.

Mr. Karon reported on the Pay-by-Phone initiative, stating that due to the growing popularity of mobile payment for meters, the Authority will be adding a new service provider, Pay-by-Phone, as an additional payment option. A resolution for the board's approval is included on tonight's agenda.

He also noted that, based on historical usage and payment trends, several parking meters around the university area had previously been removed in favor of mobile payment only. This approach has proven successful, and the program will now be expanded to additional streets in the university area.

Mr. Karon reported that the sale of the second Ferren parcel was completed on June 3. Construction has since begun on the Nokia building. Upon receipt of the sale proceeds, the Authority paid off two outstanding notes totaling approximately \$5 million.

Mr. Karon reported that Mr. Rajaratnam has informed the Authority of his decision to depart at the end of August. The process of finding a replacement for the CFO position is currently underway. Mr. Karon expressed his gratitude to Bright for his hard work and significant contributions to the success of the Authority, noting that he will be greatly missed.

Finance

Mr. Rajaratnam reported that the 2024 audit is nearly complete. They are currently waiting for the state report, which is expected to arrive within a week of the beginning of August.

Legal

Public Comment

A member of the public inquired about the total debt of the Parking Authority. Mr. Rajaratnam responded that the total debt is \$187 million.

A member of the public inquired about the grocery store space, asking if there are any current plans and whether there has been any public engagement. Mr. Karon responded that they are not currently engaging with the public. He stated that they are actively seeking a tenant but are also considering converting the space into additional parking.

A member of the public inquired about ParkMobile, asking if there has been another known security breach or hack in the system. They mentioned that a similar incident occurred about three years ago, or possibly in 2018, and wanted to bring it to the committee's attention.

A member of the public inquired about the Mayfair lot and asked about the current plans, referencing a statement by the Planning Director that the Parking Authority intended to build a parking garage on the site. Mr. Karon responded that discussions are still ongoing regarding the potential development of the site. He noted that while City Council has approved the development plans, the project remains in the planning stage. Mr. Karon emphasized that the need for additional parking in town is growing, with Nokia opening and bringing approximately 500 employees, the new Rutgers building scheduled to open next year, and continued growth at the hospital. Due to this increased demand, the Authority is considering the construction of another parking garage.
