Executive Director's Report

Mr. Karon states that there has been an increase in demand at the Lower Church Street Deck, specifically on the weekend. There is an average of 250 cars per night Thursday – Sunday.

Alternate side of the street parking begins again on April 1st. In anticipation of this, the NBPA is looking to hire another Parking Enforcement Officer since we reduced staff when the pandemic began.

Rutgers is purchasing three floors at Gateway. The closing date is set for April 1st and the NBPA should be receiving about \$6 million in the sale.

Last year the Board approved the policy to allow employees to be paid out for any additional vacation time beyond the 2 weeks at a 50% value in an effort to keep employees on the job. Mr. Karon states the NBPA would like to extend this policy for this year as well. The Board is in agreement and approves the policy.

Public Comment

A member of the public expresses opposition to cutting the Board Meetings down to six times a year.

A member of the public asks for an update on the former Ferren Site. The Board advises the Public should direct questions regarding the site to DEVCO since the development is being directed by them and not NBPA. Member of the public states that the area is in need of redevelopment and the results have been unsatisfactory. Member of the public suggests the Board should choose a different developer or have an open process to find a developer.

A member of the public asks if the NBPA will be able to make this year's pilot payment. Mr. Karon states the NBPA plans on making the payment in full.
