### Board Meeting Minutes May 28, 2025

A regular meeting of the New Brunswick Parking Authority was held on May 28, 2025, in the conference room of the New Brunswick Parking Authority, located at 106 Somerset Street, New Brunswick, New Jersey. General Counsel Aaron Rainone called the meeting to order at 5:03 p.m.

#### **Minutes**

On motion of Ms. Eato-White, seconded by Mr. Zimmerman, the board approved the minutes from the March 2025 regular board meeting. Vote: 3 - yes, 0 - no, 0 - abstain, 2- absent.

### **Executive Director's Report**

Mr. Karon reported that the 2025 restoration work has begun at the Gateway Garage. A key challenge will be applying traffic coating at the exit turn on the first level. This work will require redirecting traffic within the garage and will be scheduled during overnight hours to minimize disruption to patrons.

Mr. Karon reported an update on EV charging stations. The Authority is exploring the possibility of outsourcing station management to a vendor called Green Spot. This company installs, operates, and maintains EV stations, while also managing pricing and payment systems. The arrangement would include a revenue share agreement, which may be more advantageous than NBPA owning the infrastructure and covering maintenance and electricity costs. Green Spot currently operates in Edison, Jersey City, Trenton, Tenafly, Milford, Long Branch, and Asbury Park.

Mr. Karon reported on the Installation of the LCSD system is scheduled for Monday, June 2. Additional staff will be on-site that day to assist patrons entering and exiting the garage. Parking demand at this location is typically low on Mondays, with the garage reaching only half capacity during the day.

Mr. Karon reported that the current Solar Power Purchase Agreement (PPA) is set to expire on July 14 at the Plum Street Garage and on December 3 at the New Street Garage. The Authority will be going out to bid in an effort to secure a new PPA. Once the current agreements end, the existing supplier is expected to remove the solar panels from both garage locations.

### **Public Comment**

A member of the public inquired about the total debt of the Parking Authority. Mr. Rajaratnam responded that the total debt is \$187 million.

A member of the public inquired about the dismissal of a parking ticket issued on January 3rd. They noted that the ticket contained two signatures and requested the identity of the second signer. Mr. Karon stated that he would follow up and provide that information.

A member of the public asked for a follow up regarding the Middlesex County Municipal Joint Insurance Fund (JIF). They inquired about the Parking Authority's transition from the previous JIF to the current Mid JIF, and whether there have been any noticeable differences or impacts. Mr. Karon responded that the new JIF is working well so far. He noted that Mid JIF provides a variety of training opportunities and has introduced an Employee Assistance Program (EAP) to support staff.

A member of the public inquired whether the Executive Director, Mr. Karon, was aware of any plans for new parking structures in New Brunswick, or any potential development of the **former** engineering building owned by the Authority. Mr. Karon responded that while future demand is being considered, there are currently no definite plans, and discussions are still in the early stages.

A member of the public suggested that future board meetings be offered in a hybrid format, allowing attendees to join remotely. Mr. Rainone responded that the Board members could discuss that internally.
