Board Meeting Minutes October 22, 2025

A regular meeting of the New Brunswick Parking Authority was held on October 22, 2025, in the conference room of the New Brunswick Parking Authority, located at 106 Somerset Street, New Brunswick, New Jersey, Chairman Kevin McTernan called the meeting to order at 5:00 p.m.

Chairman Kevin McTernan read the public statement as required by P. L. 1975.

Minutes

On motion of Mr. Zimmerman, seconded by Mr. Sleiman, the board approved the minutes from the September 2025 regular board meeting. Vote: 5 - yes, 0 - no, 0 - abstain, 0- absent.

Executive Director's Report

Mr. Karon reported on the elevators. Last month, he noted that the NBPAC elevator and one of the Gateway elevators had been out of service for a longer than usual period while waiting for repair parts to arrive. He now reports that the NBPAC elevator is back in service, and the Gateway elevator is scheduled to be repaired next Wednesday.

Mr. Karon reported that, as a way to increase revenues, he would like to explore the opportunity of adding advertising within the garages. He noted that the empty walls inside the garages are well-suited for advertising and that the billboards on the exterior of some garages have already proven to be effective revenue generators at no cost. Mr. Karon believes similar results can be achieved inside the garages and stated that he will be issuing an RFP to determine if there is interest from providers of this service.

Mr. Karon reported on Green Spot, noting that the company was previously selected as the provider of EV charging stations. He stated that he is currently working on a lease agreement with Green Spot to install EV charging stations within the parking garages. The agreement will be structured as a revenue sharing arrangement, with Green Spot covering the costs of the charging stations, installation, maintenance, and electricity.

Mr. Karon reported that the current Collective Bargaining Agreement (CBA) with Maintenance and Custodial personnel is set to expire at the end of the year. He noted that negotiations for a new agreement will begin shortly.

Mr. Karon reported that the 2024 Audit has been completed, and an exit conference was held with the auditing firm. He noted that there were no findings or recommendations resulting from the audit. A resolution is included on today's agenda requesting board approval of the audited financial reports.

Mr. Karon reported that the 2026 budget has been completed. He noted that a resolution is included on today's agenda requesting the board's approval of the budget.

Mr. Karon reported on the Local Finance Board (LFB), noting that the last resolution on the agenda pertains to the Parking Authority's application to the LFB for approval of its designation by the city as the redevelopment entity for the New Redmond II project. He stated that a closed session meeting will be held on this matter prior to voting on the resolution.

Public Comment

A member of the public inquired about the Chief Financial Officer (CFO), asking whether he is an employee or a contractor and if the position had been advertised. Mr. Karon responded that Mr. **Tricarico** is an employee and confirmed that the position had been advertised.

A member of the public asked who currently serves as the Enforcement Lieutenant. Mr. Karon stated that Naudia Harris is the Operations Manager and that she oversees the Enforcement Department.

A member of the public stated that he had submitted an OPRA request seeking information regarding the training received by enforcement officers. Ms. Perez noted that the Authority is currently working on fulfilling that OPRA request.

A member of the public inquired about the eligibility determination that requires the Police Chief's sign-off, citing Statute 40:11A, and asked whether it applies to the New Brunswick Parking Authority. Mr. Rainone stated that it is his position that the Authority is in compliance.

A member of the public inquired about total debt of the Parking Authority. Mr. Tricarico responded that it is \$181,216,000 million.

A member of the public inquired about updates on the supermarket space. Mr. Karon responded that there is no update.



FOR CERTAIN REDEVELOPMENT PROJECTS BEING UNDERTAKEN IN THE CITY OF NEW BRUNSWICK

WHEREAS, the City Council of the City of New Brunswick, in the County of Middlesex, a municipal corporation of the State of New Jersey (the "City"), pursuant to N.J.S.A. 40:11A-4.1 of the Parking Authority Law, N.J.S.A. 40:11A-1 et seq. (the "Parking Authority Law"), desires to authorize the Parking Authority of the City of New Brunswick (the "Parking Authority") to serve as a redevelopment entity to effectuate the purposes of the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1 et seq. (the "Redevelopment Law"), for various redevelopment projects within the City; and

WHEREAS, on September 17, 2025, the City, pursuant to N.J.S.A. 40:11A-4.1 of the Parking Authority Law, adopted a bond ordinance authorizing the Authority to serve as a redevelopment entity under the Redevelopment Law, and to exercise redevelopment powers within an area in need of redevelopment or an area in need of rehabilitation in the City; and

WHEREAS, in accordance with N.J.S.A. 40:11A-4.1 and N.J.S.A. 40A:5A-1 et. seq. (the "Local Authorities Fiscal Control Law"), the Authority desires to make an application ("Application") to the Local Finance Board, in the Division of Local Government Services, New Jersey Department of Community Affairs (the "Local Finance Board") for its review and approval of an ordinance appointing the Parking Authority to serve as a redevelopment entity in lieu of the City pursuant to the Parking Authority Law, the Redevelopment Law, and the Local Authorities Fiscal Control Law to implement redevelopment plans and carry out certain redevelopment projects within the City; and

WHEREAS, the Authority believes that:

- (a) it is in the public interest to accomplish such purpose; and
- (b) said purpose is for the health, wealth, convenience or betterment of the inhabitants of the City and the users of the Authority's parking facilities; and
- (c) the amounts to be expended for said purposes are not unreasonable or exorbitant and will inure to the benefit of the inhabitants of the City and the users of the Authority's parking facilities; and

- (d) the purpose is an efficient and feasible means of providing services for the needs of the inhabitants of the City or upon the users of the Authority's parking facilities and will not create an undue financial burden to be placed upon the City or upon the users of the Authority's parking facilities; and
- (e) the implementation of redevelopment projects is in the best interests of the City and its residents.

Any previous actions taken by officials and representatives of the Authority related to the preparation and submission of the Application are hereby ratified and confirmed.

Section 3. The Executive Director, Chairman, Vice Chairman, Treasurer and Secretary of the Authority are each hereby authorized to approve the Application, execute and deliver all necessary documents required to complete such Application, and to file (or cause to be filed) such Application with the Local Finance Board.
