## Minutes of a Regular Board Meeting September 22, 2021

A regular meeting of the New Brunswick Parking Authority was held on September 22, 2021, in the conference room of the New Brunswick Parking Authority, located at 106 Somerset Street, New Brunswick, New Jersey. Chairman Kevin McTernan called the meeting to order at 5:00 p.m.

#### **Minutes**

On motion of Mr. Keefe, seconded by Mr. Garlatti, the board approved the August 2021 regular board meeting minutes. Vote: 3 - yes, 0 - no, 0 - abstain, 2 - absent (Caputo, Eato-White).

## **Executive Director's Report**

Mr. Kennedy reported that the impact of the remnants of Hurricane Ida on the NBPA was limited to elevator damage and cleanup costs caused by flooding at the New Street Deck, along with some water intrusion from above in an elevator shaft at the Paterson Street Deck. There were no reports of damage to NBPA or customer vehicles at any of the parking facilities.

Effective September 1, the Liberty Lot transitioned to a 100% touchless payment methodology via the parking app, and revenue collected through the third week of this month is 42% higher than the same timeframe last month.

Overall parking facility revenue in August was 7.5% higher than July's total and more than double the amount collected in August 2020.

## Finance

Mr. Rajaratnam stated that the NBPA still is waiting for the OPEB report from the state in order to complete the NBPA's 2020 audit. He noted that it appears that the report will be released in December.

#### **Public Comment**

A member of the public thanked Mr. Kennedy and Mrs. Hart for their responsiveness to requests for information.

A member of the public asked if the NBPA was aware of any forthcoming announcements or ceremonies regarding the former Ferren site. Mr. McTernan stated that anything like that would be orchestrated through DEVCO and that they would be able to provide information regarding that. He stated that he had not received an official notification of any groundbreakings.

A member of the public asked if there were any plans to go back to monthly board meetings. Mr. McTernan stated that the board would continue having meetings about every 60 days and that, when the need changes and activity levels increase to an extent that requires a monthly meeting, the NBPA would do so and announce it on all the available public channels.

A member of the public asked to confirm the continuation of the policy that attendees of NBPA board meetings can have their parking validated. The board confirmed that this policy was still in effect.

A member of the public inquired whether Mr. Caputo was still on the board or just absent. Mr. McTernan advised that Mr. Caputo was not available to attend the meeting.

A member of the public asked for the parking authority's total debt. Mr. Kennedy stated that bonds payable was at \$227,340,000.

A member of the public asked if the NBPA would continue to work with THA Consulting. Mr. McTernan stated that THA currently has one assignment with the NBPA, which they are in the process of completing, and that they do not have any other business on the docket with the NBPA. Mr. Kennedy confirmed that this was the case, noting that they had a single assignment from the prior executive director back in May and that nothing further has been undertaken with them.
