#### Board Meeting Minutes September 25, 2024

A regular meeting of the New Brunswick Parking Authority was held on September 25, 2024, in the conference room of the New Brunswick Parking Authority, located at 106 Somerset Street, New Brunswick, New Jersey. General Counsel Aaron Rainone called the meeting to order at 5:00 p.m.

#### **Minutes**

On motion of Ms. Soto, seconded by Mr. Sleiman, the board approved the minutes from the July 2024 regular board meeting. Vote: 3 - yes, 0 - no, 1 - abstain, 1- absent.

#### **Executive Director's Report**

Mr. Karon reported that the restoration and maintenance work has been completed at the Paterson Street Garage, Civic Square Garage, Morris Street Garage, and Church Street Garage.

Mr. Karon reported on EV charging stations, highlighting two resolutions on today's agenda related to a state grant to replace single-port stations at the Wellness and Gateway garages with dual-port machines. This upgrade will increase the number of ports from 5 to 10 at each garage. The other garages already have dual-port stations, which were replaced in 2020, so their installation will not be covered by the grant due to the recent replacement.

Mr. Karon reported on statistical information regarding the parking system, covering both off-street and on-street parking. Overall, 91% of all transactions are made via credit card payment. For on-street meters, 63% of transactions are completed using the pay by phone app, while 28% are conducted with an actual credit card at the meter.

Mr. Karon reported on operations, announcing the recent hiring of Naudia Harris as the new Operations Manager, replacing Antoine Johnson. In her role, Naudia will oversee both the Enforcement and Parking Services Departments. She brings extensive parking experience from her previous work with private parking operators.

#### Finance

Mr. Rajaratnam reported that the 2023 audit is finalized. There will be an exit conference with the finance committee on October 9th.

#### Legal

No legal to report.

#### **Public Comment**

A member of the public inquired about the EV charging stations, specifically regarding whether the grant is from the federal or state government and if there is a fixed amount for the grants. Mr. Karon stated that it is a state grant, while the federal government provides tax credit. Additionally, each grant is capped at \$40,000.

A member of the public inquired about the total debt and whether payment was made in August. Mr. Rajaratnam stated that the total debt remains \$194,000,000, and a payment is scheduled for September. Additionally, a member of the public asked about the audits, specifically if they were clean and if there were any findings. Mr. Rajaratnam confirmed that the audit is clean.

A member of the public inquired about updates on the supermarket space. Mr. Karon stated that they are currently negotiating a lease.

A member of the public inquired about the changes made downtown regarding ordinances for accommodating delivery drivers and drop-off procedures, asking how the implementation has progressed. Mr. Karon stated that enforcement began yesterday, as the city only put up the necessary signage that day. He mentioned that more information will be provided at next month's meeting.
