Board Meeting Minutes September 18, 2025

A regular meeting of the New Brunswick Parking Authority was held on September 18, 2025, in the conference room of the New Brunswick Parking Authority, located at 106 Somerset Street, New Brunswick, New Jersey. Chairman Kevin McTernan called the meeting to order at 5:00 p.m.

Chairman Kevin McTernan read the public statement as required by P. L. 1975.

Minutes

On motion of Mr. Zimmerman, seconded by Mr. Sleiman, the board approved the minutes from the May 2025 special board meeting. Vote: 3 - yes, 0 - no, 2 - abstain, 0- absent.

On motion of Mr. Zimmerman, seconded by Ms. Soto, the board approved the minutes from the May 2025 regular board meeting. Vote: 3 - yes, 0 - no, 2 - abstain, 0- absent.

On motion of Mr. Sleiman, seconded by Ms. Soto, the board approved the minutes from the July 2025 regular board meeting. Vote: 3 - yes, 0 - no, 2 - abstain, 0- absent.

Executive Director's Report

Mr. Karon introduced the new CFO, James Tricarico.

Mr. Karon reported that the 2025 Restoration Project has been completed. The team is now moving forward with a physical assessment in preparation for the 2026 restoration. As part of ongoing efforts to maintain facility conditions, power washing of the exterior at both the New Street and Church Street garages will begin shortly.

Mr. Karon also provided updates on elevator service issues at both the New Brunswick Performing Arts Center (NBPAC) and the Gateway Garage. The elevator at Gateway has been out of service for several weeks and requires a new motor, which is currently on order with an estimated lead time of six to eight weeks. At NBPAC, the elevator became inoperable after a group of individuals jumped inside, causing it to stop between floors. Emergency responders had to cut through the roof of the cab to assist a person who was feeling faint. As a result, the elevator roof must now be replaced, which also has a six-to-eightweek lead time. A new roof with an integrated escape hatch has been ordered to help prevent similar incidents in the future.

Mr. Karon, regarding infrastructure improvements, noted that installation of the new Parking Access and Revenue Control System (PARCS) has been completed at the Plum Street Garage. The Gateway Garage is next in line, with installation expected to be completed during the first quarter of 2026.

Mr. Karon, in response to increased demand for mobile payment options, announced that a third service provider, Passport, will be added to the existing parking payment system. This enhancement will give parkers the option to choose from three mobile payment providers ParkMobile, PayByPhone, and Passport for both on-street parking and at the NBPAC Garage. A resolution seeking board approval for the addition of Passport is included on the agenda for this evening's meeting.

Mr. Karon also discussed the ongoing planning for the Mayfair Lot. Conceptual drawings are currently being developed for a new parking garage at the site. This facility will support an upcoming project by AST on New Street and provide additional parking space for Robert Wood Johnson. With the Helix development currently underway, additional parking will be required. As a result, RWJ's parking will shift from the Wellness and Gateway garages to the proposed Mayfair Garage upon its completion.

Mr. Karon noted that he and James are actively working on the 2026 budget, with the goal of having a finalized proposal ready for board approval at next month's meeting.

Public Comment

A member of the public inquired about the total debt of the Parking Authority. Mr. Tricarico responded that it is \$187 million.

A member of the public inquired about updates on the supermarket space. Mr. Karon responded that there is no update.

A member of the public handed out documents relating to a parking ticket he received. He distributed a resolution approved in January, along with a ticket summons. Mr. Rainone clarified that while members of the public are allowed to present information during meetings, it is not intended to be a back-and-forth discussion. He noted that the Board may choose to respond, but the meeting is not a Q&A session.

A member of the public inquired about how an individual can be designated as a Parking Enforcement Officer. Mr. Rainone explained that individuals are hired directly into the position and are designated as such upon hiring. He further stated that they are authorized under the law to issue parking tickets.

A member of the public handed Mr. Rainone a document citing statute 40:11A. Mr. Rainone explained that the statute referenced in the document pertains specifically to municipalities. He clarified that, by ordinance, the municipality has already delegated certain powers and responsibilities to the Authority, as permitted under the statute, without the need for separate eligibility determinations. Mr. Rainone further stated that the portion of the statute cited applies to municipalities, not the Authority directly. He concluded by noting that the question being posed veers into legal interpretation, and as such, constitutes a request for legal advice which is not appropriate during a public meeting.

On motion of Mr. Sleiman, seconded by Mr. Zimmerman, the board approved authorization of the auction of Surplus Automobiles and Equipment (Generators). Vote: 5- yes, 0 - no, 0 - abstain, 0- absent.
