#### **Summary**

We collected the D16 aquatic site McRae Creek under clear skies today. This completes D16 collections with full coverage of all sites under green conditions.

#### **Concerns**

- -The waveform digitizer was not functional today. Waveform pulses were not seen during the first air-test, so the digitizer was restarted. It seemed functional after pulses were seen on the 2<sup>nd</sup> air-test, but no pulses were seen on the first survey line. Power was cycled twice and software was refreshed as well. The digitizer would connect to the software but would not acquire data. No waveform was collected for today's flight.
- -During the loiter for the waveform troubleshooting, a NIS framegrabber error occurred. Cycling switches 5 and 6 resolved the issue.

#### **Comments**

- -Because collections have been completed 7 days ahead of schedule, the team is looking at the next logistically feasible step.
- -Abe arrives today to replace Mike.






