Summary of SB 907:

- SB 907 (Pan) improves access to healthy foods for all California families, regardless of income, as well as increases the number of farmers' markets throughout California.
- Makes it easier for certified farmers' markets in California to provide electronic benefits transfer (EBT) services to support families in need of food assistance.
- Increases CalFresh access at farmers' markets which helps small and mid-sized farmers.
- Allows more low-income households to access locally grown, affordable, fresh and healthy food.

Background SB 907:

CalFresh — or the Supplemental Nutrition Assistance Program (SNAP) — is a very successful anti-poverty program that benefits communities of color, immigrants, seniors, college students, and other food insecure Californians. CalFresh participants receive an EBT (electronic benefits transfer) card to access their food benefits, and recent data shows that CalFresh households are increasingly shopping at farmers' markets. However, many farmers' markets do not have the administrative capacity to overcome the hurdles required to successfully and efficiently provide EBT at their markets. Providing easier access to EBT not only benefits small and mid-sized farmers; it also allows more low-income households to access locally grown, affordable, fresh and healthy food in their own community.


