### OCTO CORPORATION PRIVACY POLICY

Effective From: 2<sup>nd</sup> June, 2023

Octo Corporation, accessible from the platform <a href="www.octocoporation.com">www.octocoporation.com</a> ("the site"), is committed to protecting your privacy. We have prepared this Privacy Policy to describe to you our practices regarding the Personal Information (as defined below) we collect from users and how we treat it.

#### PERSONAL INFORMATION WE COLLECT

When you visit the Site, the types of Data we Collect is as follows:

- "Contact Information" means data that allows someone to identify or contact you about our products and services, including, for example, your name or e-mail address.
- "Anonymous Data" means data, including aggregated and de-identified data, that is not associated with or linked to your Personal Data; Anonymous Data does not, by itself, permit the identification of individual persons. For example we automatically collect certain information about your device, including information about your web browser, IP address, time zone, and some of the cookies that are installed on your device. Additionally, as you browse the Site, we collect information about the individual web pages or products that you view, what websites or search terms referred you to the Site, and information about how you interact with the Site.   via email, we will collect your name and email address, as well as any other content
  included in the email, in order to send you a reply. Additionally when you make a
  purchase or attempt to make a purchase through the Site, we collect certain information
  from you, including your payment information (such as, Metamask or Eth address).

# INFORMATION COLLECTED ABOUT YOU FROM OUR SERVICE PROVIDERS

We may also receive Personal and/or Anonymous Data about you from companies that provide our Services by way of a co-branded or private-labeled website or companies that offer their products and/or services on our Site. For example, for conducting cryptocurrency transactions, we use third-party electronic wallet extensions such as (but not limited to) MetaMask; your interactions with MetaMask and/or any third-party electronic wallet extensions are governed by their applicable privacy policies. ### HOW DO WE USE YOUR PERSONAL INFORMATION?

We use the Personal Information that we collect generally to fulfil any orders placed through the Site (including processing your payment information, sending products to you and providing you order confirmations). Additionally, we use this Information to:

- Communicate with you;
- Screen our orders for potential risk or fraud; and
- Provide you with information or advertising relating to our products and services.
- We use the Anonymous Data that we collect to help us screen for potential risk and fraud (in particular, your IP address), and more generally to improve and optimize our Site (for example, by generating analytics about how our community of followers interact with the Site, and to assess the success of how we communicate with you by such methods as marketing and advertising.

## **SHARING YOUR PERSONAL INFORMATION**

We share your Personal Information with third parties to help us use your Personal Information only for the above purposes. For example, we use 3<sup>rd</sup> party Analytics Software to help us understand how our customers use the site.

We may transfer or assign this Privacy Policy and any Personal Information to a third-party entity in connection with a merger, acquisition, consolidation, restructuring, the sale of substantially all of our shares and/or assets, in connection with bankruptcy proceedings, reorganization, or other change of control events.

Finally, we may also share your Personal Information to comply with applicable laws and regulations, to respond to a subpoena, search warrant or other lawful request for information we receive, or to otherwise protect our rights.

Other Disclosures. We may also disclose your Personal Data, to fulfill the purpose for which you provide it; for any other purpose disclosed by us when you provide it; or with your consent.

### **MINORS**

Our Site is not intended for children. You must be at least 18 years old to access this Site or mint an Octo Corp NFT. By accessing the Site, you represent and warrant that you are at least 18 years of age. We do not intentionally gather Personal Data from visitors who are under the age of 18. If a child under 18 submits Personal Data to our company and we learn that the Personal Data is the information of a child under 18, we will attempt to delete the information as soon as possible. If you believe that we might have any Personal Data from a child under 18, please contact us.

# **INTERNATIONAL USERS**

If you are a non-U.S. user of the Site, by visiting the Site and providing us with data, you acknowledge and agree that your Personal Data may be processed for the purposes identified in the Privacy Policy. In addition, your Personal Data may be processed in the country in which it was collected and in other countries, including the United States, where laws regarding processing of Personal Data may be less stringent than the laws in your country. By providing your data, you consent to such transfer.

## **YOUR CONSENT**

By submitting Personal Information through our Site or providing Personal Information to our Service Providers for the Site, you agree to the terms of this Privacy Policy and you expressly consent to the collection, use and disclosure of your Personal Information in accordance with this Privacy Policy.

#### HOW WE PROTECT YOUR PERSONAL INFORMATION

We take reasonable technical and organizational measures to guard against unauthorized or unlawful processing of your personal data and against accidental loss or destruction of, or damage to, your personal data. While no system is completely secure, we believe the measures implemented by the Site reduce our vulnerability to security problems to a level appropriate to the type of data involved. We have security measures in place to protect our user database and access to this database is restricted internally. However, it remains your responsibility to maintain good internet security on your own device.

- Opt-Out. We may use some of the information we collect for marketing purposes, including to send you promotional communications about the Project features, products, events, or other opportunities. If you wish to stop receiving these communications or to opt out of use of your information for these purposes, please follow the opt-out instructions by clicking "Unsubscribe" (or similar opt-out language) in those communications.
- Stop Cookies. If you decide at any time that you no longer wish to accept Cookies from our Service for any of the purposes described above, then you can instruct your browser, by changing its settings, to stop accepting Cookies or to prompt you before accepting a Cookie from the websites you visit. Consult your browser's technical information. If you do not accept Cookies, however, you may not be able to use all portions of the Service or all functionality of the Service.
