These Terms of Use are entered into by and between you (“you” or “your”) and Nori LLC, a Washington limited liability company (“Company,” “Nori,” “we,” or “us”). The following terms and conditions (“Terms of Use”/ “Terms”), govern your access to and use of www.nori.com and any affiliated websites (collectively, the “Website”).

By using the Website, you: (a) acknowledge that you have read and understand these Terms of Use; (b) represent that you have the capacity to enter into a binding agreement; and (c) accept these Terms of Use and agree that you are legally bound by them. If you do not, or cannot, agree to these Terms of Use, do not use the Website.

**15. General Terms.**

15.1. Entire Agreement. These Terms and the Privacy Policy constitute the entire agreement between you and Nori with respect to your use of the Website, and supersede all prior or contemporaneous understandings and agreements, whether written or oral, with respect to the subject matter contained herein. Your obligations to indemnify Nori, along with any other part of these Terms of Use which, by their nature should survive termination of these Terms or your right to use the Website, shall survive.

15.2. No Assignment. These Terms and any rights or licenses granted to you herein are personal to you, and may not be assigned prior to obtaining Nori's written consent.

15.3. Arbitration. PLEASE READ THIS SECTION CAREFULLY. IT AFFECTS YOUR RIGHTS AND INCLUDES WAIVER OF A TRIAL BY JURY IN A COURT AND OF THE ABILITY TO BRING A CLAIM ON BEHALF OF OTHERS. Any disputes or claims arising from the use of the Website, including disputes arising from or concerning their interpretation, violation, invalidity, non-performance, or termination, will be resolved by binding arbitration under the Federal Arbitration Act, federal arbitration law and rules, and Washington state law. To the fullest extent permitted by law: (a) no arbitration under these Terms shall be joined to any other arbitration; (b) no class arbitration proceedings will be permitted; (c) no finding or stipulation of fact in any other arbitration, judicial or similar proceeding may be given preclusive or collateral estoppel effect in any arbitration hereunder (unless determined in another proceeding between you and Nori); and (d) no conclusion of law in any other arbitration may be given any weight in any arbitration hereunder (unless determined in another proceeding between you and Nori). Both parties will be responsible for their respective arbitration fees.

15.4. Governing Law and Jurisdiction. These Terms are governed by and construed in accordance with the Federal Arbitration Act, federal arbitration law, and the laws of the state of Washington without giving effect to any choice or conflict of law provision or rule. Notwithstanding the foregoing, Nori retains the right to bring any suit, action or proceeding

against you for breach of these Terms in your country of residence or any other relevant country.

15.5. Injunctive Relief. You agree that Nori may bring suit in any court of competent jurisdiction in order to enjoin infringement or other misuse of Nori's or its affiliates or licensor's intellectual property rights.

15.6. Limitation on Time to File Claims. ANY CAUSE OF ACTION OR CLAIM YOU MAY HAVE ARISING OUT OF OR RELATING TO THESE TERMS OR THE WEBSITE MUST BE COMMENCED WITHIN ONE (1) YEAR AFTER THE CAUSE OF ACTION ACCRUES, OTHERWISE, SUCH CAUSE OF ACTION OR CLAIM IS PERMANENTLY BARRED (if applicable law prohibits a one (1) year limitation period for asserting claims, the claim must be asserted within the shortest time period in excess of one (1) year that is permitted by applicable law).

15.7. Waiver and Severability. No waiver by Nori of any term or condition set forth in these Terms shall be deemed a further or continuing waiver of such term or condition or a waiver of any other term or condition, and any failure by Nori to assert a right or provision under these Terms shall not constitute a waiver of such right or provision. If any provision of these Terms is held by a court or other tribunal of competent jurisdiction to be invalid, illegal or unenforceable for any reason, such provision shall be eliminated or limited to the minimum extent such that the remaining provisions of the Terms of Use will continue in full force and effect.
