NeighborShare connects neighbors in need with people who want to help-quickly, directly, and with trust. Vetted, local nonprofit partners identify pivotal, time-sensitive needs like a \$350 car repair to keep a parent employed, a \$150 certification fee to secure a better job, or \$400 to help someone safely leave an abusive situation. These needs are uploaded to NeighborShare's platform, where donors fulfill them in real time. By removing red tape and channeling support directly to families, NeighborShare prevents small, unmet needs from becoming crises. Every contribution reaches the individual or family directly and provides immediate, stabilizing impact. Since its inception, NeighborShare has distributed over \$1 million to more than 10,000 neighbors nationwide, including \$325,375 in FY2024 alone.
