PRIVACY POLICY AND TERMS OF USE

1. INTRODUCTION

51C Collaborative, Inc. doing business as Oath ("Oath", "Oath.Vote", "we", "our" or "us") is committed to protecting your privacy. We provide grassroots donor advising services to our clients.

This Privacy Policy explains how your personal information is collected, used and disclosed by Oath. This Privacy Policy applies to our Oath mobile application (the "App"); the Oath website at <u>oath.vote</u>, including its mobile version (the "Site"); and any other website, product or service that links to this Privacy Policy (collectively, including the App and the Site, our "Service").

By logging into this website and using the Site, you agree to be legally bound by this Privacy Policy and Terms of Use. You also agree to be bound by other legal notices that may be posted on this Site from time to time. Oath does not provide Personal Information collected about you to candidates, political parties, or organizations that you contribute to using the Site, other than partners that you specifically opt-in to.

We are committed to protecting your privacy online. By providing Personal Information to us, you agree to these Terms.

The Site is directed to users in the United States only.

## 2. UPDATES TO THE TERMS

Please review these Terms periodically because we modify them from time to time.

Each time you visit this Site or provide us with information through the Site, by doing so you are accepting practices described in the Terms in effect at that time.

3. USE OF THE SITE

The purpose of Site is to facilitate contributions to candidates, organizations, and causes that our proprietary algorithm recommends to our clients, which are drawn from the general public. You may not sell or offer to sell access to Site. You agree not to use the Site to:

- access or forward personally identifiable information about any person to any other person;
- engage in advertising to, or solicitation of, any other persons to buy, or sell any product or services, including posting advertisements and/or solicitations of business;
- generate any content, including but not limited to, personal or organizational fundraising pages that are inconsistent with our Anti-Hate Speech policy found in Section 4 below;
- use this Site in a manner inconsistent with any and all applicable laws and regulations of any country;
- impersonate any person or entity, real of fictitious, or falsely state or otherwise misrepresent your affiliation with a person or entity;
- stalk, abuse (or attempt to abuse), or otherwise harass another person;
- make unauthorized use of our trademarks or service marks;
- upload, post, e-mail or otherwise transmit or create any content that contain any viruses,
   Trojan horses, worms, spyware, time bombs, cancel bots or other computer programming routines that are intended to damage, detrimentally interfere with, surreptitiously intercept or expropriate any system, data or personal information;

- Reporting Violations: Users are encouraged to report any instances of hate speech or inappropriate content to our platform for review. Reports will be investigated, and appropriate action will be taken as deemed necessary by the platform.

We collect information you give us when you register on our Site, contribute using our Site, or contact us. We do not collect credit or debit card information. Any payment information is securely processed and stored via our payment processing vendors.

You can access some parts of the Site without registering and becoming a user ("User"), but you must become a User to access certain services offered on the Site, including tracking previous contributions that You have made using the Site. Certain information will be stored as a ("Guest") if you choose to not become a User right away.

During the registration process, you will be prompted to provide Personal Information to us, which will be stored with your email address. You will need to sign-in by providing a code that will be emailed to your email address in order to access your account.

Do not use another User's account or email address at any time, or share your access codes to any third party. Please notify Us immediately if you suspect any unauthorized use of your membership or access to your account. You should never respond to an online request for an access code other than in connection with the log-on process for the Site. Your disclosure of your access codes to any other person is entirely at your own risk. - As we believe to be necessary or appropriate: (a) under applicable law, including laws outside your country of residence; (b) to comply with legal process; (c) to respond to requests from public and government authorities including public and government authorities outside your country of residence; (d) to enforce our terms and conditions; (e) to protect our operations or those of any of our affiliates; (f) to protect our rights, privacy, safety or property, and/or that of our affiliates, you or others; and (g) to allow us to pursue available remedies or limit the damages that we may sustain.
