## **NFHS Rules**

- 1. R1 muffs a kickoff at R's 10 YL. R3 intentionally kicks the loose ball into R's EZ. K4 recovers the ball in R's EZ. The R signals a TD for K. Ruling: Incorrect. In 2014 this is now a TB. The ball retains its status as a kick and force is not a factor. If the foul for illegal kicking is accepted it is enforced from the previous spot and the down will be replayed with a 15 YD penalty. Rule: 2-24-9.
- 2. A, 3/6 @ B's 25 YL.: 03 remain in the 3Q. A1 throws a long pass, A2 is flagged for holding and B3 is flagged for a 5 yard facemask during the play. Time expires during the down. The **R** signals the fouls offset and then raises the ball signaling the end of the period. **Ruling: Incorrect. Since there was a double foul on the play and time expired during the down the period will be extended for an untimed down.** *Rule: 3-3-3-b.*
- 3. A, 3/6 @ A's 8 YL. A1 fumbles the ball and the ball is rolling slowly on A's 3 YL. A2 is trying to get to the ball and he pushes B3 into the ball and the ball rolls into A's EZ. A6 recovers the ball in the EZ and is immediately downed. The R signals a TB since B3's touching of the ball caused the direction of the rolling ball to change. Ruling: Incorrect. This is a safety. The initial force is A's fumble. The accidental touching by B3 doesn't constitute a new force. Rule: 8-5-1-b
- 4. A, 3/25 @ A's 30 YL. A1 (passer) is rolling out and as he starts to run B2 grabs A1's facemask and twists it. A1 breaks free and then completes a short pass to A2 at A's 35 YL who is immediately hit and fumbles the ball. A3 then recovers the ball at A's 37 YL. The crew enforces the penalty at the spot where A3 recovered the fumble. Ruling: Correct. This is a foul for roughing the passer (not just a 15 yd. facemask). The enforcement spot is the dead ball spot since the pass was complete & there was no COP. This also includes an automatic first down. Therefore, the result of the play is A, 1/10 @ B's 48 YL. Rule: 9-4-4 and 10-5-5
- 5. Good Penalty enforcement question... TRICKY! A, 1/10 @ A's 45 YL. A1 is sacked @ A's 35 YL. During the down A2 is guilty of an illegal block below the waist @ A's 47 YL. The crew enforces the foul from the 47 YL. Ruling: Incorrect. We must remember the foul is enforced from where the run ends on a running play. Therefore, the foul is enforced where A1 was sacked, A's 35 YL. The result of the play if the foul is accepted is A's ball 1/35 @ A's 20 YL. Rule: 10-3-2
- 6. A, 2/20 @ B's 25 YL. A breaks their huddle and comes to the line. All the A lineman stand straight up. A1 says "set" and all A lineman go into a 3 pt. stance except guard A2 who is arranging his shoulder pads. A3 goes in motion after which A2 goes into his 3 pt. stance. The ball is snapped while A3 is still in motion. A1 throws a TD pass to A4. No flag is thrown. Ruling: Incorrect. A is guilty of an illegal shift. All 11 players must come to an absolute stop and remain stationary for at least 1 second after the shift. If accepted the TD is nullified and the 5 yd. penalty is enforced from the PS. Rule: 7-2-6.
- 7. A, 1/10 @ A's 45 YL. B1 intercepts A1's forward pass @ B's 35 YL. B1 runs the ball to A's 20 YL where A2 grabs and turns B1's facemask and B1 fumbles the ball. While the ball is loose, B3 clips A3 @ A's 25 YL. A4 recovers the fumble and is tackled at A's 17 YL. Ruling: Double Foul. The fouls offset. Neither team has an option. The down is replayed at the previous spot. Since A fouled prior to gaining the last possession they do not have the ball "with clean hands". Rules: 2-16-1b & 10-2-2-a

## **OHSAA Mechanics**

- 8. The **BJ** has to signal a foul prior to a KO. He has the KT's ball in his hands. He tosses the ball to the kicker and then signals the foul and then asks the kicker for the ball and walks off the penalty yardage. **Incorrect- The BJ must lay** the ball on the ground. Then signal the foul to the PB. Pick up the ball from the ground and walk off the yardage. *Gold book: page. 18- #27.L.*
- 9. A's ball 1/10 @ B's 13 YL. The **BJ's** pre-snap IP is on the GL. Ruling: **Incorrect- When the ball is snapped** between the +15YL and the +10YL the BJ's IP is 5 yds. deep in the EZ. Gold book: page 21- #31.B.4.

## **OHSAA Regulations**

10. During a down a whistle is heard in the VT stands. Ignore the whistle. Ruling: Stop play and apply the inadvertent whistle rule. Report this to Game Management. Gold Book: Pg. 37 #24.
