- 9. Other Quizzes: New Rules, Basic Penalty Enforcement (PE), followed by more complex PE. Timing Rules. Develop questions from common situations that we have on the field.
- 10. 2021: Jerry -- Mechanics (A G), Regulations (A G); Greg Mechanics (H P), Regulations (H P); Eric -- Mechanics (R W), Regulations (S W). Early Quizzes should emphasize Changes from last year.
