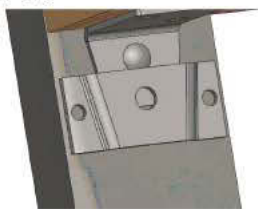

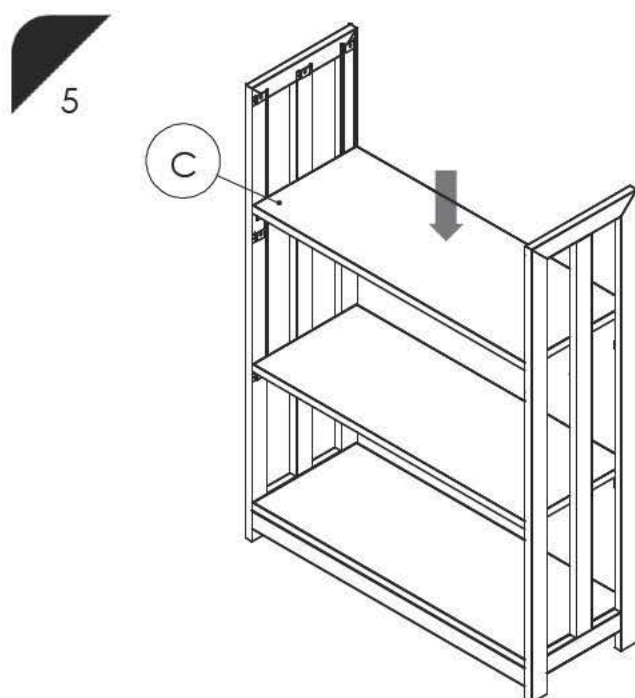

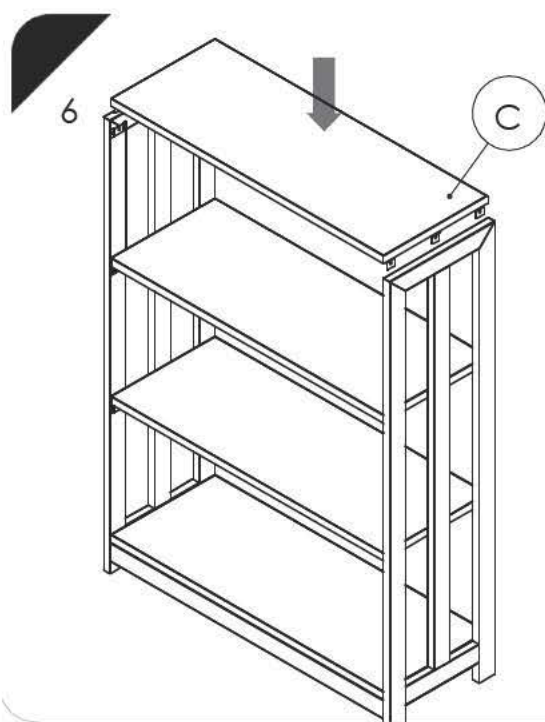

### WARRANTY DURATION:

- **5 YEARS:** Desks, hutches, panels and file cabinets
- **1 YEAR:** Plastic caps, locks, hinges, fabric, casters, wood seats and accessories. Sienna chair A501

### LIMITATIONS:

- Damage caused by the carrier-in-transit is handled under separate terms as defined by the carrier

### EXCLUSIONS:

- 1) Damages resulting from improper product installation, assembly or disassembly
- 2) Normal wear and tear as expected over the course of ownership
- 3) Modifications or attachments to the product not approved by CRISA
- 4) Product used for rental purpose

### WARRANTY WILL NOT BE APPLICABLE IN THE FOLLOWING CASES:

- 1) Products that were not installed, used or routinely and properly maintained in accordance with product instructions and warnings.
- 7) Product used in different conditions than intended.
  - 1) Product not assembled according to the provided written instructions.
  - 2) Product changed or repaired by non CRISA authorized personnel
  - 3) Defects occurring after the purchase by natural disasters, product modification, intentional damage, accident, misuse, abuse, negligence or exposure to the elements.
  - 4) Damages caused by third party carriers other than Creaciones Industriales S.A DE C.V.

- 4) A customer service representative or CRISA will determine whether to provide replacement parts, authorize repairs or replace the product provided CRISA affirms that the product in question is eligible under the conditions of the warranty as stated above.
- 5) CRISA will review the defect and determine whether it is related to material or workmanship. If the defect is not related to manufacturing, cost of replacement parts and shipping will be the customer's responsibility.
