## Section 4. First aid measures

### Description of necessary first aid measures

## Section 7. Handling and storage

### Precautions for safe handling

Avoid the creation of dust when handling and avoid all possible sources of ignition (spark or flame). Prevent dust accumulation. Use only with adequate ventilation. **Appropriate engineering controls** : Use only with adequate ventilation.
