11.4 TRANSPORT BUDGETS 2024 – 2027

Approval for a course of action that reconciles the financial aspects of the GPS with the Council's Long-term Plan 2024/34 was sought.

- 1. Receive the report.
- 2. Agree to approve the following, to be included in the forthcoming Annual Plan:
 - a. Wi Neera Dr to Onepoto Shared Path. Defer the \$6.39m local share until at least 2026/27.
 - b. Kenepuru Dr intersections with Titahi Bay Rd, Lyttleton Ave and Lower Main Dr.
 - No structural change in the short term, but upgrade the existing Kenepuru Dr pedestrian (zebra) crossing to a signalised crossing and continue to monitor the intersections.
 - ii. Retain funding for property as this work needs to continue for long term decisions.
 - iii. Defer the local share to at least until 2026/27.
 - c. <u>Low Cost Low Risk programme.</u> Use the local share (3.29m) to implement the speed management plan, school safety programme assets and react to essential safety issues.
 - d. <u>Transmission Gully Link Roads (Waitangirua Link Road and Te Ara Kāpehu).</u> Fund the local share needed (\$0.14m) to fully utilise the Waka Kōtahi subsidy, and bring forward 2026/27 LTP funding to 2025/26.
 - e. <u>Renewals.</u> Deploy the LTP budget to maintain levels of service, including a \$6.25m portion over three years that will not be subsidised.

11.1 ANNUAL PLAN 2025/26

Council agreement to the proposed approach for the Annual Plan 2025/26 was sought.

RESOLVED 2024/56

That the Council | Te Kaunihera o Porirua:

- 1. Receive the report.
- 2. Note that the 2024-34 Long-term Plan indicates a 10% rate increase for 2025/26. This follows a 17.5% increase in 2024/25.
- 3. Note that this report highlights both cost pressures and potential savings that are included in the draft Annual Plan 2025/26. As a result, there may be a net decrease of 3.25%, which lowers the suggested rate increase from 10% to 6.75%.

- 4. Note there is some uncertainty around cost pressures influenced by external factors beyond Council's control. Officers will continue to monitor these factors throughout the Annual Plan process.
- 5. Approve depreciation-funding assumptions (\$1.2 million adjustment).
- 6. Note that the Financial Strategy will be updated to reflect the new depreciation assumption and that this will be communicated at the same time as the consultation of the draft Annual Plan.
- 8. Note that Local Water Done Well options will be consulted at the same time as the draft Annual Plan.
- 9. Note that additional operational budget has been proposed by Wellington Water Limited as outlined in paragraph 28. This is excluded from the draft Annual Plan.

SECRETARIAL NOTE: During the vote on Clause 7d, the meeting, with the consent of the mover and seconder of the motion, substituted Clause 7d to remove "Young People's Fund – Tier 1 – \$ 100,000" and "Young People's Fund – Tier 2 – 36,000".

This resulted in the total for Clause 7d being \$170,000 (instead of the \$306,000 in the Chief Executive's recommendations). The amended substantive is shown below:
