1.I object to the inclusion of part of 1 Jones Deviation Pauatahanui in the Special Amenity Landscape designation .I am seeking this designation be removed from the plan in relation to 1 Jones Deviation.

#### **Reason for objection**

The plan currently includes a part of 1 Jones Deviation in The Special Amenity Zone. I request that it be removed form the zone because;

- a) The property is a considerable distance from the Pauatahanui Inlet. It is not adjacent to the inlet.
- b) the part of Jones Deviation included in the designation is not highly visible from the inlet or elsewhere.
- c)there are no significant areas of native vegetation on the land.

#### **Objection**

Once a building is placed on the land it will almost always be visible. The land has been modified for the forseeable future. Colour is a very subjective matter. The imposition of colour palettes whether by the council or developers is turning Porirua into a very grey, characterless and uninteresting place.




