Queen Elizabeth the Second National Trust (QEII) is an independent charitable trust that partners with private landowners to protect natural and cultural heritage sites on their land with covenants. The general functions of the Trust are to encourage and promote, for the benefit and enjoyment of the present and future generations of the people of New Zealand, the provision, protection, preservation, and enhancement of open space.

QEII owns 29.7 hectares of a lowland wetland (Taupō Swamp) between Plimmerton and Pukerua Bay, which is protected as open space. The entire Taupō Swamp wetland complex (43 ha) is a nationally representative example of a topogenous lowland freshwater mire (peat forming wetland) and is an Outstanding Natural Wetland.

There are also 26 registered QEII covenants within the PCC district, protecting over 70 hectares of open space. QEII is also the holder of a licence to occupy from Kiwirail over the Paekākāriki Escarpment, managing the site in partnership with Ngā Uruora for the protection of indigenous biodiversity values.

QEII is interested in ensuring the PCC DP provides for protection of the outstanding values of Taupō Swamp, maintenance of Te Awarua-O-Porirua, and protection of significant natural areas and significant natural wetlands within the Porirua district.
