Kainga Ora's proposals for medium and high density residential zones are inappropriate for much of Porirua, particularly for the Paremata and Plimmerton areas. The number of properties suitable for medium or high density development in these areas is so few that creating these zones (with all the associated downsides, including destruction of village character) is simply not justified – despite the need for additional housing. Instead, it would generally be better to create such zones within newer or planned greenfield areas where the developments can be better planned and the extra population will help make public transport services more viable.
