Memorandum on behalf of Kāinga Ora – Homes and Communities – Hearing Stream 4

- 1 In the Appendix to this memorandum, Kāinga Ora lists the submission points that it is seeking to be deferred. The submission points have been organised by the provisions to which they relate.
- 2 Kāinga Ora does not know which hearings different submission points have been allocated to so it has made some assumptions, including:
 - (a) submission points on the objectives and policies listed relating to the GRZ and MRZ chapters are presumably intended to be in Hearing Stream 7. They have been listed in the Appendix for completeness and in case that assumption is not correct.
 - (b) How different hearing points are allocated is a matter for the Panel, but it may make sense not to defer only those submission points listed but, for example, the entire noise chapter to enable a chapter-wide consideration at the appropriate time.
