This submission is in support of the new Rural Lifestyle Zone classification in the proposed Porirua District Plan.
We strongly support the introduction of the Rural Lifestyle Zone classification in the proposed District Plan. We also strongly support the properties on Bradey Road, Pauatahanui being included in the Rural Lifestyle Zone, as indicated in the proposed District Plan.
