3. PEFC REPORT UPDATE

To reappoint Mr Michael Proschek-Hauptmann, as members of the PEFC Council Board of Directors for a further three-year period (2015-2018).

Motion 7: To endorse the SGEC forest certification scheme, subject to the fulfilment of the two following conditions within six months after a scheme endorsement:

- a) SGEC shall actively engage with the AINU Association of Hokkaido in order to develop a mutually acceptable solution for the recognition of AINU people's rights in the SGEC forest management standard.
- b) SGEC shall bring the wording of the requirements concerning conversion in full compliance with PEFC's requirements (PEFC ST 1003:2010, 5.1.11)

Out of 96 possible votes, 65 For, 0 Against, 0 Abstention

Motion 8: To endorse the revised system of PEFC Germany, subject to the fulfilment of three conditions:

- a) To ensure that non-conformity by the forest owner identified under one forest management certification is addressed in any other forest management certification that covers the forest owner. (PEFC ST 1002:2010, 4.1.2)
- b) To define and include the transition date in the forest management standards PEFC D 1001 and PEFC D 1002-1. (PEF ST 100:2010, 6.2)
- c) To enter into a discussion with PEFC International and resolve the issue of the" Regional Labelling" and the labelling in context of the recreation forest.

Conditions a) and b) shall be fulfilled by PEFC Germany within six months after reendorsement. The fulfilment of the conditions shall be verified by the PEFC Secretariat.
