## VISION & MISSION

With the arrival of 2025, the Diocese of Toronto is moving into a new and exciting phase of its strategic plan, Cast the Net.

The 20 Calls, which were endorsed by Synod along with the strategic plan in 2023, encourage Anglicans in all parts of the diocese to renew their spiritual lives, to seek justice for all, to support faithful and fruitful ministry, and to live and work as the body of Christ, each connected to the whole and each valued for their unique gifts.

The group is hoping that parishes will embrace one or more of the calls this year. Parishes can choose calls that they are already involved in or take up new ones – whatever best suits their capacity, context and vision.







## **BISHOPS' MESSAGE**

To the clergy, churchwardens, and parishioners of the Diocese of Toronto: Beloved Siblings in Christ,

"...be renewed in the spirit ..." Ephesians 4:23

In this Season of Spiritual Renewal, the Diocese of Toronto is exhibiting a burgeoning health and vitality that inspires us daily. To God be the glory! As your bishops, as we travel around to visit our parishes, we have witnessed the Holy Spirit engaging in marvelous ways with people, groups and ministries right across this Diocese – from Mississauga to Minden, from Cobourg to Collingwood. The Season of Spiritual Renewal, this invitation to spiritual growth, has been enthusiastically received in so many ways, including the sharing of prayer resources, participation in online workshops, and our bishops' Advent study online.







We are also looking forward to **#LiveLent: God's Story, Our Story, a** daily Lenten resource with a helpful guide for small group use.

We are excited that the next phase in this Season of Spiritual Renewal is called "Lift Up Our Hearts." Over the coming year, large worship services will take place across the Diocese on five Saturday afternoons at 2 p.m. Each celebration of the Eucharist will feature excellent music, moving testimony, and preachers from within our own Diocese, each with their own unique approach to spiritual renewal. We hope you will plan to join us for one or more of these marvelous gatherings. Come on your own, bring a friend, or hire a bus! We will see you there:

- March 22 St. James Cathedral (preacher: the Rev. Molly Finlay)
- March 29 Trinity Church, Streetsville (preacher: the Rev. Canon Stephanie Douglas)
- May 31 All Saints, Whitby (preacher: the Rev. Gerlyn Henry)
- September 27 St. James, Orillia (preacher: the Rev. Dr. Rob Hurkmans)
- October 25 St. Paul's, Bloor Street (preacher: the Rev. Dr. Alvardo Adderley)

The call to spiritual renewal, however, was just the first of 20 Calls articulated in the Cast the Net strategic vision adopted by Synod and this Diocese in 2023. Over the coming year, you will hear us repeatedly emphasising the need for each congregation to review and consider all of the 20 Calls and then choose which two or three your parish will focus on.

As you gather today for Vestry, this could be the perfect opportunity to start considering the question. A small group – the Netminders – has prepared resources to help you, which you can find on the <u>Cast the Net web page</u>. While it's important to remember that no congregation could possibly answer all 20 Calls, we strongly believe that each congregation can consider two or three. Leading up to our diocesan Synod in November, we hope that every parish will be able to identify which of the Calls they are living into.

We are pleased to welcome our new Executive Director, Varun Balendra ODT. A familiar face around the Diocese, Varun has served in many volunteer capacities over the years, and we look forward to working together in this new capacity. By the time of our diocesan Synod on Friday, Nov. 7 and Saturday, Nov. 8, we expect that we will be introducing a new Secretary of Synod and a new full-time Diversity, Equity and Inclusion Advisor, whose primary focus areas will be supporting the work of the Anti-Bias, Anti-Racism (ABAR) and other DEI training, and supporting individuals and parishes to grow, build community, educate and engage.

Some other new faces at Synod may include guests from the Diocese of

Brasilia. This past June, at the Cathedral Church of the Resurrection in the city of Brasilia, the two diocesan bishops of Brasilia and Toronto signed the covenant that brings our two dioceses into a companion relationship. Since the signing of our agreement, a small representative group from each diocese has been meeting monthly – in both Portuguese and English – to pray together and to plan events. For example, clergy from both dioceses will gather online for a joint study day on liberation theology on March 25. In the fall, a youth delegation from Brasilia will join our own youth at the Re-Charge youth retreat at Muskoka Woods camp. And we anticipate sending a delegation from Toronto to Brasilia in 2026. We have even developed a shared logo for our relationship that combines elements of each of our own logos: our Diocese of Toronto dove springing from their Ipe Tree. You can expect to hear more about this companion partnership as we enter into the second year of it.

Closer to home, the partnerships within our own Diocese continue to flourish. When we speak of casting the net, we are referring to the supportive, creative and collaborative ministry that occurs in each deanery and regionalization, between parishes and congregations, amongst church neighbours and colleagues. We are grateful to our hardworking and devout clergy and our dedicated lay leaders, especially churchwardens, treasurers, administrators, musicians and the countless church staff and parish volunteers who are Christ's hands and feet of ministry in our communities. We are so grateful for all of your faithful work in our parishes and beyond.

We have embarked on a feasibility study to discern if this is the right time for the Diocese to conduct a major financial campaign. Over the next six months, M&M International, a Toronto-based fundraising firm, will listen to parishes large and small, soliciting feedback on a case for support.

It is proposed that if a campaign does go forward, the majority of funds raised will remain in the parishes, with a smaller portion supporting the 20 Calls at the diocesan level. Your feedback and commitment will make the difference as we look into this additional way of working together.

Lastly, we want to encourage each Vestry meeting to consider this year's social justice motion: "Protecting and Expanding Harm Reduction in Ontario." The Church has a role to play in calling on government for responsible actions in caring for our most vulnerable neighbours, to ensure life-saving protections for those experiencing addictions and other challenges. Please consider how your parish can speak up, and out, for those who require advocacy. As we anticipate going to the polls in the coming year – federally and provincially – let us remember our baptismal promises as we cast our ballots, choosing candidates who align with our values. And let us pray for them.

For it is in praying that we are drawn ever deeper into relationship with the Triune God and become more attentive to the will of our Heavenly Creator. In this Season of Spiritual Renewal, we ask every reader of this letter to commit more deeply to a life of prayer, that it may infuse your every day with Grace as you witness to the Love of Christ in your life and to the world.

In your prayers, please pray for all three of us, your College of Bishops, both in your personal daily devotions as well as your parish's weekly intercessions. Know that we are praying for you too, giving thanks for our common life together across our wonderful diocesan family.

## **RECTOR'S REPORT**

In November 1953, a Sunday school opened in what was then the Crang Auditorium; with the purpose of serving the community in the area where our present parish would come to be located. On May 2nd 1954, the Rev. Frank Weston Fry and his family arrived in the parish to a service of reception. Then, on May 9th 1954, the first regularly held services began in a portable church; the foundations of the present-day worshipping community of St. Stephen, Downsview.

Commencing on October 1st 2023, and continuing through to October 31st 2024, our parish community of St. Stephen, commemorated 70 years as a Christian community of faith, under the theme: "Three Score and Ten: Walking Wisely in the Light of the Lord." During this year of celebrations, we were pleased to be led in mission by The Rev. Kenneth Korsah; Priest of the Ghanian Anglican Church in Canada, and also by the Rev. Canon Leonard Abbah and the Rev. Canon Dr. Stephen Fields.

The Rt. Rev. Andrew Asbil; Diocesan Bishop for the Diocese of Toronto, graciously consented to be our preacher and celebrant at our parish's anniversary service on May 12th, 2024; and we were truly delighted to have so many friends and visitors join us for the celebrations on that occasion. The year was also marked by many other opportunities for thanksgiving and celebration including our annual walk-a-thon, a parish clean-up day, a trip to Sight & Sound Theatre in PA to see the live production of Daniel, and, to culminate the year, a parish banquet – an Evening of Elegance – attended by just under 200 members, and friends! We are profoundly grateful for God's faithfulness to His mission and our ministry with this community over the past 70 years, and we look forward in hope to the continuance of the

#### same in the years to come!

I am pleased to report that our ministries have remained consistent over the past year; serving those both within and beyond our walls. I know that I have been personally delighted to see many return to their ministry roles in this post-pandemic period, and many others come alongside to offer themselves for the work at hand. Our Altar Guild, Welcomers, choir, counters, readers and intercessors, Sunday school and acolytes have all continued faithfully in their work; supported by the efforts of our music team, staff and Parish Administrator, Wardens and other volunteers working behind the scenes. This year we were pleased to have the added technical support of a new group of volunteers from the congregation who were trained to manage the livestream week-byweek.

To this end, I continue to be grateful for the faithful and steady support of our Corporation, Advisory Board and Administrative team. Our Wardens – Orphtee, Shalon and Ericka – have faithfully and effectively discharged their duties; guietly, and selflessly in the service of God and of this congregation. They are owed a profound debt of gratitude. Our Advisory Board members – Fanella, Nadeen, George, Connie, Patricia, Cheryl, Bosun and Ebele – by their counsel and advice, have helped to keep the concerns of the Parish at the forefront of our work together. Our Parish Administrator, Greg, has continued to go above and beyond in helping us to improve our internal processes and operations in general. With his guidance and under his oversight, a number of training videos have been produced which will help to support present and future volunteers to become more effective and efficient when engaging the ministries and operations of the parish. Our Custodian, Allan – again effectively, quietly, and selflessly – has ensured that our worship space and our facilities in general, are clean, ready and available for worship week-by-week.

Our weekday offerings of morning and evening prayer continue on Zoom, Monday to Friday at 7:15am, and Sundays at 6pm, respectively. The Tuesday evening prayer and Bible study group, led by Beverley

Brown and Ezekiel Ekeh, continues week-by-week at 7pm; now on Zoom.

Our Thursday evening Bible study continues to meet via Zoom at 7:30pm. This past year we studied Paul's letter to the Ephesians, the Book of Daniel, and the Book of Job. At present, we are studying Paul's letters to the Colossians and Philemon.

Our Saint's Café has continued faithfully over the past year to serve thousands of pre-packaged meals and grocery items to an everincreasing number of friends from the surrounding community and beyond. As a parish community we remain grateful for the dedication of our Coordinator, Patricia, and her faithful and joyful team of volunteers who offer this ministry week-by-week.

Their work is supported by donations and other contributions from our community partners: Black Creek Community Health Center (BCCHC), Elizabeth House, North York Harvest Food Bank, Second Harvest Food Bank, TAIBU Community Health Centre and many others!

We were privileged this year to participate once again in Prison Fellowship Canada's (PFC's) Angel tree program for the 8th year, sponsoring 7 children across 4 families; both here in Toronto, and beyond. Aspirationally, we hope to begin partnering with PFC in both inprison ministry, and ministry to those recently released. We also hope to begin reaching out more intentionally to serve the seniors' care homes and other institutions within our community. We give God thanks for these growing opportunities for ministry and outreach.

We are also thankful to God for the steady progress we have made in maintaining and improving our worship space in support of all the ministry outlined above. As a Corporation, and having received a mandate from our last Vestry meeting in 2024, we have begun – with the support of grant funding – to undertake a feasibility study and preliminary costing estimate for the renovation of our kitchen and other spaces at the basement level, along with a consideration for the installation of a Limited Use Limited Application (LULA) elevator. More

information will be shared with the Parish community in the coming months as it becomes available. It is our belief that any renovation work undertaken by the Parish needs to be comprehensive and forwardlooking in its anticipation not only of present needs, but of the needs for the next 70 years and beyond!

We have inherited a wonderful tradition of worship and of commitment to serving the community and beyond. It is a tradition of which we should be proud! As we move forward, ever-leaning on and following our Lord who leads us, it is my hope and prayer that what we have received, and continue to build upon, will continue to serve the generations to come. I am grateful for the privilege to serve as your Incumbent, for your support as fellow laborers in this part of God's vineyard, and for the support of my family; who often and patiently bear the weight of my absences.

#### The Corporation

The Corporation, consisting of Rev. Father Theadore Hunt (Incumbent), Emeka Ichoku (People's Warden, until June 2024), Orphtee Quarcoo (Rector's Warden), Shalon Jeffers (Deputy People's Warden), and Ericka Martin (Deputy Rector's Warden), met monthly throughout the year, with additional meetings convened as needed.

#### 2024 Advisory Board

#### **Church Maintenance, Repairs, and Other Projects**

Various maintenance and other projects were undertaken and completed in 2024, including:

- Replacement of the side door
- Sound system upgrades
- Installation of the front facing livestream camera
- Transition to a new donation management system
- Ongoing streamlining of financial management processes, supplemented by a thorough audit completed by an external Accountant

- Development of a comprehensive training programs for various ministries in the church including the Welcomers, Livestreaming, Counting ministries
- Engaged the services of an Architect to develop preliminary drawings for future comprehensive renovations to the parish hall
- We extend our gratitude to our Sexton, Allan Austin, for his unwavering commitment to maintaining the church property.

#### The Rectory

We are diligently planning the renovation of the church's rectory and actively seeking funding opportunities to commence the project. Meanwhile, regular visits to the property have been conducted, along with routine maintenance tasks such as lawn care and snow removal.

#### **Ministry Partnerships**

Thanks to our ongoing partnerships with Black Creek Community Health Centre and Prison Fellowship Canada, we were able to minister to many individuals in the community and beyond through the Saints Café and the Angel Tree Program. We are grateful to the dedicated volunteers for their time and talent in supporting these meaningful ministries.

#### **Parking Lot**

We continue to have several individuals renting parking spots. The income generated from these rentals will be used to maintain the parking lot and fund other capital projects.

The Corporation is dedicated to preventing unauthorized parking on the property. We continue to refine our system, which includes ticketing unlawfully parked vehicles, to effectively manage spot rentals.

#### Outlook for 2025

As we look forward to the year ahead, our hope is to continue to build on all that we achieved as a parish in 2024.



The Wardens would like to extend their heartfelt thanks to the members of St. Stephen, Downsview for their continued prayers, love, support, and collaborative efforts towards the parish's successes over the past year. With God's help, we are very hopeful for all that can and will be accomplished in 2025 for our church, our community, and beyond.

## CHARITABLE GIVING

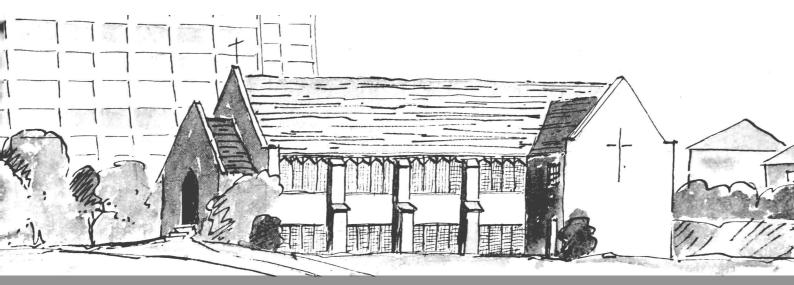

At CSSD children and youth ministry has always been an important ministry. Children grow up in the Church and develop strong bonds with each other that they continue into adulthood. We may not see them weekly or as often as we would like, but the bond to the Church is never broken.

During the pandemic we pivoted to online Sunday School which was well attended. It has been a couple of years since we resume in-person Sunday School. In addition, it is my hope to one day soon transition the coordination and management of CSSD Sunday School to someone who loves and is as committed to it as I am. Until then we will continue to meet and teach our children about the love of Jesus.

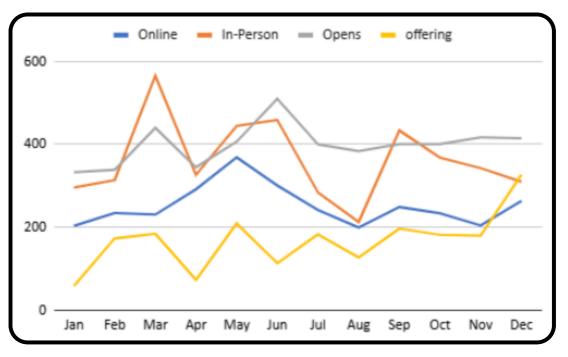

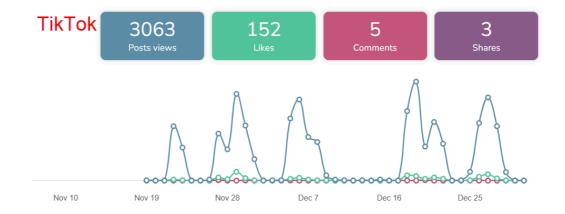

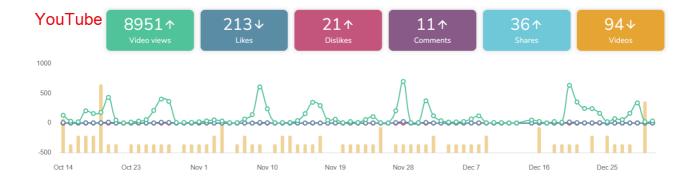

No surprise, the most popular page is the announcements.

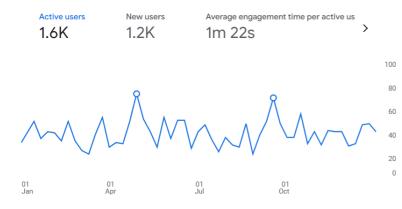
Note that the second most popular pages are pages about who we are. The photos in this report come from those page... so... the photos matter and YOU matter to people who are seeking a relationship with church.



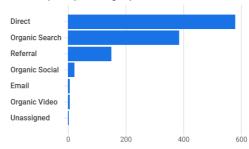

The CRA also tolerates an exception for projects interrupted by COVID (this applies to MOSS and WOSS) but expects the balance carried over to decline year-to-year and eventually reach zero.

The Community Services Recovery Fund (CSRF) was a one-time grant from the Government of Canada, administered by the Unity Way, to support charities and non-profits as they focus on how to adapt their organizations for pandemic recovery.

The "focus" has three areas, of which applicants must choose one:

- Focus Area A: Investing in people
- Focus Area B: Investing in systems and processes
- Focus Area C: Investing in program and service innovation and redesign

Project expenditures must adhere to the scope outlined below; improvements to the church property and rectory are ineligible, and we will have to report project progress to the United Way. See the PDF on <u>eligible and ineligible</u> costs for details.

Our COVID experience taught us that we need to blend online and inperson to reach and serve our community for worship and community service. "Program delivery redesign" (Area C), aims to increase the comfort level of our pool of potential volunteers with new tech and methods, and reduce our cost by aligning our tech and processes with our current and future needs.

The CSRF project completed June 2024. If you sum the balances on the previous page, you will notice that the total cost to St Stephen's was \$145.

Fr. Hunt expressed his gratitude to Ericka Martin for the service she has given in the role as Deputy People's Warden.

Fr. Hunt will also appoint three Advisory Board Members At Large. Iris Linton will be taking a step back from the role of Envelope Secretary, a role that she has held for many years. Iris has committed to training the person or persons who step into the role. Fr. Hunt provided a quick overview of the position prior to asking for nominees from the floor.

Fr. Hunt provided a brief explanation of the role of the Parochial Tribunal.

#### **Corporate Reports**

#### Incumbents Report

Highlights of the Incumbent's report are as follows:

Fr. Hunt indicated it has been a year of growth. We have had many new friends, locally and internationally, that have joined us weekly for worship and other services either in person or via live stream. There has also been a steady return to ministries, in particular several new young servers who are currently preparing for Easter. Thankful for the 40 days of giving to make our Easter celebration a grand one.

Fr. Hunt also shared his pleasure with the steady support from the Corporation and the Advisory Board throughout the past year, in front and behind the scenes. Gratitude was also given to Canon Peter for his service by stepping in on the Sundays when the Rector was away. Acknowledgement to Bev, Connie and Emeka for their support of leading services and morning prayer last Summer.

We continue to offer online services and amenities, morning prayer, midweek prayer and bible study groups. We are open to other opportunities to meet virtually.

Fr. Hunt flagged the work of the Saints Café. The program is currently at, if not over, capacity. There is a lot of work to be done and volunteers are always needed. One year ago, we set out to hire a volunteer coordinator to alleviate some pressure for our coordinator, but that did not materialize. We continue to move forward but recognize that structural changes (kitchen capacity) and volunteer resources are required. Members are encouraged to read the Wardens report for an update regarding the Rectory. A loan hasn't been secured to renovate the property, but we have been working to make sure the property does not deteriorate. In addition to regular site visits, the Wardens have procured the following updates: a new water heater and furnace were installed, and



locks were changed. We remain hopeful that we can approach another lender to secure a loan for the renovation.

Because the Rectory is currently vacant, we have been flagged for the vacant home tax. While we will see if there is anything we can do to reverse this decision, it impresses upon us that we need to do all we can to move this project along.

There have been stringent efforts by the Corporation to connect with the Downsview Youth Covenant (DYC) regarding their status as we have not received any lease payments for a while. As stewards of this property, we have determined not to renew the lease agreement with DYC and will have to find new tenants. We recognize the important work of the DYC, and the Corporation has decided that when the DYC is able to return as paying tenants, we will extend that privilege to them.

Property improvements at the Church include replacing lights with new LED lights, new motion detector, smoke alarms, aluminium gutters and downspouts as our copper downspouts were stolen. We are grateful to Foster Odlum and his contact who helped us to replace the side door. We appreciate the donation as we only had to pay for the hardware. As a tribute to our late sister Violet, the flower beds have been built and ready for the Spring.

As part of our 70th anniversary celebrations, we have identified the following projects for the coming year: property perimeter fencing, new accessible deck, parking lot resealing and restriping.

The following questions or comments were received from the floor:

- Allan Austin: Regarding DYC it hurts my heart to hear this is what it has come to. DYC has supplies and furniture, what will happen to those things?
  - As per the lease they are given time to remove any equipment and supplies they have on site. The move can be coordinated with our office.



- Maraval Odlum: <u>Saints Café has reached capacity</u>, <u>what is capacity</u> <u>and what happens next</u>?
  - There are new patrons coming every week. We have reached the limits what we can accommodate. Unless we can get more volunteers and an updated kitchen, we may get to a point where we won't accept any further new patrons.
- Patricia Adams: We don't want to turn anyone away. The main challenge is to get the kitchen renovated. The renovated kitchen should include larger sinks, proper stoves, and industrial equipment. There is also a need for a regular chef.
- Beverly Brown: <u>Can we get help from the Diocese or Black Creek</u> <u>Community Centre</u>? Consider changing how we distribute e.g., only one meal per person, can only collect for yourself.
  - These are all very real concerns. Last year architect helped us to understand distinction between calling it a kitchen and an industrial space. It is a big undertaking to install industrial equipment at a basement level. We will have to revisit building code, fire capacity etc. Such a renovation will cost hundreds of thousands of dollars. Is this the direction we want to go in or something simpler? If it is the will of the Vestry, we can investigate to see what it might cost us. This will be a significant undertaking.
- **Ebele Felix**: Suggestion that we explore what grants are available to us. Investigate how other churches/organizations have organized such projects.

Fr. Hunt invited question or comments regarding the remaining reports found on pages 12-20 and 28-30.

#### **CSRF** Grant

Greg Watson, the Parish Administrator, provided an update regarding the Community Services Recovery Fund (CSRF) grant. This is a grant from the federal government that is administered by the United Way.



The purpose of the grant is to regularize lessons learned from the pandemic. The grant was used to improve our live stream, cameras in the front and side of the Church, a new sound system and a new envelope software. Greg shared highlights of the report including attendance stats and plans to launch a spiritual renewal. Fr. Hunt thanked Greg and encouraged everyone to read the report if they haven't already.

#### **2023 Financial Reports**

Bosun Williams, Treasurer, presented the 2023 financial statements and the 2024 budget. Fr. Hunt provided the following notes/points of clarification:

- The auditor is still working on the audit but anticipate that it will not change materially from what we have prepared so we can accept financials as presented.
- Although we are completing an audit, the Diocese has removed the requirement of audit for parishes with an annual income under \$500,000.

Fr. Hunt thanked Bosun, Greg and Iris and everyone who assist us with the financials.

**MOTION to accept the financials statements of 2023 and the 2024 Budget**, as presented, and to reappoint Janice Charko as auditor for the year ended December 31, 2024, moved by Iris Linton, seconded by Irene Garnett. The Motion was **CARRIED**.

#### Motion to Extend the Meeting

**MOTION to amend the adjournment time** of the 2024 Vestry Meeting with a 30-minute extension from 2:00 p.m. to 2:30 p.m., moved by Emeka Ichoku, seconded by Nadeen Murray. The Motion was **CARRIED**.

#### **Other Business**

Fr. Hunt reminded us of Greg's presentation and his reference to a season of spiritual renewal. You will hear more about this in the coming



weeks and months. Over the next two years the Diocese will engage in a season of renewal. Parishes will be invited to engage in renewal of participation in activities, prayer, worship, study of scripture and most importantly in sharing our witness with those who may not know. We are hopeful it will be a season that will draw all of us in. We need to begin to think about what it is that we can do at St. Stephen, Downsview to develop those practices that develop renewal in this community.

The Scrutineer, Janet Morrissey, provided the results of the election of the Lay Representative to Synod. George Quarcoo was elected.

The meeting adjourned at 2:11 p.m. with a prayer led by Fr. Hunt.
