**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** The Mayor and the Director of City Planning are authorized to receive seven-thousand, seven-hundred and fifty (\$7,750.00) dollars of grant funding per grant amendment between the City of Pittsburgh and the Pennsylvania Department of Conservation and Natural Resources, executed 5/19/2020, to aid in obtaining title reports for the South Side Park Master Plan. Monies from the grant agreement shall be deposited into the Grants Trust Fund account 1129400197.45505.00.

**Section 2.** The Mayor is further authorized to issue and the City Controller to countersign a warrant in favor of Title Wave in the amount of fifteen-thousand, five-hundred dollars and zero cents (\$15,500) for title searches of Southside Park, chargeable to and payable from the following accounts:
