Resolution authorizing the Mayor, Director of the Department of Public Safety, and the Chief of Police, on the behalf of the City of Pittsburgh, to enter into a grant agreement with the United States Department of Justice (DOJ) to receive monies from the 2019 Byrne Justice Assistance Grant Program and further authorizing legitimate expenditures by the Bureau of Police, for purchases authorized by the Grant Agreement and for the execution of agreement(s), or contract(s) for any equipment or services required in connection with the execution of said grant. Said agreement(s) or contract(s) shall not exceed FIFTY TWO THOUSAND DOLLARS (\$52,000).

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor, the Director of the Department of Public Safety, and the Chief of Police, on the behalf of the City of Pittsburgh are hereby authorized to enter into a grant agreement with the United States Department of Justice (DOJ) to receive monies from the 2019 Byrne Justice Assistance Grant Program, for the receipt of grant monies in the amount of FIFTY TWO THOUSAND DOLLARS (\$52,000). With this grant, the Pittsburgh Bureau of Police (PBP) will fund consultants for cold case investigations. The grant agreement shall be approved as to form by the City Solicitor and monies shall be deposited into the Grants Trust Fund 2329400363.45703.00

Section 2. The Mayor, the Director of the Department of Public Safety, and the Chief of Police, on the behalf of the City of Pittsburgh are hereby further authorized to enter into agreement or agreements, contract or contracts, and to make all legitimate expenditures required under the terms and conditions of the grant agreement with the United States Department of Justice (DOJ), Byrne Justice Assistance Grant, outlined in Section 1 of this resolution. Said agreement or agreements, contract or contracts, or expenditures, shall be approved as to form by the City Solicitor and shall be in an amount not exceed FIFTY TWO THOUSAND DOLLARS (\$52,000) chargeable to and payable from the Grants Trust Fund 2329400363.50000.00
