Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of the Department of Mobility and Infrastructure, on behalf of the City of Pittsburgh, are hereby authorized to enter into a Letter of Amendment to the agreement with the Pennsylvania Department of Transportation for ~~municipal-incurred total phase~~ **costs** associated with the Construction phase of the South Side Signals project, providing for the payment of ~~municipal-incurred total costs for the construction phase~~ thereof, not to exceed ~~Three Million Three Hundred Fifty Thousand Dollars (\$3,350,000.00)~~ **Four Million Ninety Thousand Six Hundred and Forty Dollars (\$4,090,640.00)**; account details to be authorized and encumbered on an individual service agreement basis. Funding for other phases authorized by resolutions 17-18 and 229-20.
