Ordinance accepting a new street name, WOODRING COURT in the Twenty-Third Ward of the City of Pittsburgh as per recommendation by the City of Pittsburgh Addressing Committee (CPAC). The following street name was approved by CPAC in June 2022. The name listed in this ordinance shall be made official in accordance with the Pittsburgh Code, Title Four, Public Places and Property, Chapter 420 Uniform Street Naming and Addressing.

The Council of the City of Pittsburgh hereby enacts as follows:

Section 1. That the name of WOODRING COURT, along its entire length beginning at its intersection with Suismon St at its southeasterly end to its northwesterly terminus, shall be and the same is hereby approved, located in the Twenty-Third Ward.
