Title: Resolution amending Resolution 898 of 2021, authorizing the Mayor and Director of the Department of Public Safety to enter on behalf of the City of Pittsburgh into an Amended Professional Service Agreement or Agreements with Lexipol LLC for software subscription-based policy management, wellness and training services at an overall cost to the City not to exceed FIVE HUNDRED FIFTY-SEVEN THOUSAND FORTY-NINE DOLLARS and SIXTY-SEVEN CENTS (\$557,049.67). The current agreement is being amended in order to add funds for two additional years' subscription to the Cordico Wellness App, utilized by personnel in the Bureaus of Police, Fire, and Emergency Medical Services.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of Public Safety are authorized to enter on behalf of the City of Pittsburgh into a **an Amended** Professional Service Agreement or Agreements with Lexipol LLC for software subscription-based policy management, **wellness** and training services at an overall cost to the City not to exceed ~~FOUR HUNDRED THIRTY-SIX~~ **FIVE HUNDRED FIFTY-SEVEN** THOUSAND FORTY-NINE DOLLARS and SIXTY-SEVEN CENTS (~~\$436~~**557**,049.67).

Section 2. The City Controller shall encumber funds for said **Amended** Agreement(s) subject to appropriations by City Council in respective budget years from the following chart of accounts:
