Resolution authorizing the Director of the Department of Finance and the Director of the Department of Mobility and Infrastructure, on behalf of the City of Pittsburgh, to enter into certain temporary construction easements on certain properties in the 19th Ward of the City in order to advance the Mt. Washington Landslide Remediation Project. Costs for these temporary easements shall not exceed \$2,875.00.

WHEREAS, to advance the project, access to certain parcels of property within the project area are necessary for safe movement of construction equipment in addition to grading and other construction activities, and;

WHEREAS, the City of Pittsburgh seeks to enter into temporary construction easements with various property owners in order to allow for necessary access and construction activities to advance the project.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PITTSBURGH AS FOLLOWS:

Section 1. The Director of the Department of Finance and the Director of the Department of Mobility and Infrastructure, on behalf of the City of Pittsburgh, are authorized to enter into certain temporary construction easements for construction purposes necessary to advance the Mt. Washington Landslide Remediation Project as further provided below and in the plan attached as Exhibit A.

Section 2. Costs relating to the temporary construction easements are to be paid from the following account(s), in an amount not to exceed Two Thousand Eight Hundred and Seventy Five Dollars (\$2,875.00) as indicated in the funding table:
