Title: Resolution authorizing the Mayor and the Director of the City of Planning to enter into an Agreement or Agreements with the PA Historical and Museum Commission for the purpose of receiving and spending grant funds in the amount of TWENTY THOUSAND (\$20,000.00) dollars with a local of match of FIFTY THOUSAND (\$50,000.00) for a total project cost not to exceed SEVENTY THOUSAND (\$70,000.00) dollars, to support planning efforts to create historic guidelines for three previously designated historic districts: Roslyn Place, Schenley Farms, and the Mexican War Streets Expansion.

Resolution authorizing the Mayor and the Director of the City of Planning to enter into an Agreement or Agreements with the PA Historical and Museum Commission for the purpose of receiving and spending grant funds in the amount of TWENTY THOUSAND (\$20,000.00) dollars with a local of match of FIFTY THOUSAND (\$50,000.00) for a total project cost not to exceed SEVENTY THOUSAND (\$70,000.00) dollars, to support planning efforts to create historic guidelines for three previously designated historic districts: Roslyn Place, Schenley Farms, and the Mexican War Streets Expansion.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of Department of City Planning on behalf of the City of Pittsburgh, are authorized to enter into an Agreement or Agreements with the PA Historical and Museum Commission in order to receive a grant award of TWENTY THOUSAND (\$20,000.00). Funds shall be deposited in JDE job number 1129400451.45500.00.

Section 2. The Mayor and the Director of Department of City Planning, are further authorized to enter into an Agreement, or Contract, or utilize existing Agreements or Contracts, to make all legitimate expenditures required by said Agreement(s) as outlined in Section 1. Said expenditures shall not exceed TWENTY THOUSAND (\$20,000.00) chargeable to and payable from JDE Job Number 1129400451.

Section 3. A local match of TEN THOUSAND (\$10,000) shall come from the capital budget JDE Job Number 1173830019 and a local match of FORTY THOUSAND (\$40,000) dollars from capital budget JDE Job Number 1173830120 for a total match of FIFTY THOUSAND (\$50,000) Dollars and a total project cost of SEVENTY THOUSAND (\$70,000) Dollars.
