**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** The Mayor and the Director of the Office of Management and Budget, on behalf of the City of Pittsburgh, are hereby authorized to enter into a Cooperation Agreement or Agreements with the Urban Redevelopment Authority of Pittsburgh under which the Urban Redevelopment Authority of Pittsburgh will undertake 2024 PAYGO-funded programs and projects at an amount not to exceed TWO MILLION SEVEN HUNDRED FIFTY THOUSAND DOLLARS and ZERO CENTS (\$2,750,000.00), subject to budget appropriation by City Council.
