Resolution authorizing the issuance of a warrant in favor of Kittelson, LLC for expert witness services in connection with two matters filed in the Allegheny County Court of Common Pleas at G. D. 18-0203 and G. D. 22-0077 for an amount not to exceed FOURTEEN THOUSAND SIX HUNDRED SEVENTY-FIVE DOLLARS AND THIRTY-THREE CENTS (\$14,675.33) over one year.

### Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** The Mayor is hereby authorized to issue and the City Controller to countersign a warrant in favor of Kittelson, LLC for expert witness services in connection with two matters filed in the Allegheny County Court of Common Pleas at G. D. 18-0203 and G. D. 22-0077 for an amount not to exceed FOURTEEN THOUSAND SIX HUNDRED SEVENTY-FIVE DOLLARS AND THIRTY-THREE CENTS (\$14,675.33) over one year, charging and payable from 11101.108000.53.53901.2024.
