Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the City Controller on behalf of the City of Pittsburgh are hereby authorized to enter into professional services agreement or agreements or existing agreements **with Binkley Kanavy** for **costs associated with** ~~consulting services~~ **printing and mailing the Popular Annual Financial Report**, ~~but not limited to auditing, accounting, and technical services in form approved by the City Solicitor, for services for the City Controller's Office. Said agreement or agreements shall not exceed~~ **\$19,100 for one year** ~~\$150,000.00 and are chargeable and payable from City Controller's miscellaneous services account~~ **11101.106000.53.53501.2024** ~~106000.53501.~~

Section 2: The agreements or agreements and amendments are subject to the approval of the City Solicitor as to form.

Section 3: Any ordinance or Resolution or part thereof conflicting with the provisions of this Resolution is hereby repealed so far as the same affects this Resolution.
