Resolution amending Resolution 909 of 2023, which authorized the fee schedule for 2024 pursuant to Chapter 170 of the City Code, by revising the employee parking fee as recommended by the Director of Human Resources and Civil Service.

### Be it resolved by the Council of the City of Pittsburgh as follows:

Resolution 909 of 2023, entitled “Resolution authorizing the fee schedule for 2024 pursuant to Chapter 170 of the City Code,” is hereby amended as follows:

**Section 1.** The fees for all permits, licenses, and inspections costs are hereby incorporated for the 2024 fiscal year.

**Section 2.** The effective date for the specific fee amended by this Resolution shall be August 1, 2024. The effective date for all other fees shall remain January 1, 2024.

**Section 3.** Pursuant to Chapter 170 of the City Code, codified fees shall be amended to incorporate the new fees hereby established in the 2024 fee book.
