**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** The Mayor and the Director of the Department of Mobility and Infrastructure, on behalf of the City of Pittsburgh, are hereby authorized to enter into a Reimbursement Agreement or Agreements with the Pennsylvania Department of Transportation for costs associated with the Construction phase of the North Avenue Signals and Safety Project, and providing for the payment of costs thereof, not to exceed Three Million Six Hundred Thousand Dollars (\$3,600,000.00), an increase of One Million One Hundred Thousand Dollars (\$1,100,000.00), reimbursable at eighty percent.
