Resolution authorizing the Mayor and the Director of the Department of Parks and Recreation to enter into an Agreement or Agreements with Paramount Pursuits to provide technical assistance to applicants and awardees of projects from the City of Pittsburgh's Food Justice Fund, for a sum not to exceed TWO HUNDRED THOUSAND DOLLARS (\$200,000.00) over two years.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of the Department of Parks and Recreation, on behalf of the City of Pittsburgh, are hereby authorized to enter into an Agreement or Agreements with Paramount Pursuits to provide technical assistance to applicants and awardees of projects from the City of Pittsburgh's Food Justice Fund.

Costs shall not exceed TWO HUNDRED THOUSAND DOLLARS (\$200,000.00) dollars through December 31, 2026. Funds shall be paid from the American Rescue Plan Trust Fund, JDE account 0222905500.53901.00

Section 2. Said Agreement or Agreements shall be approved by the City Solicitor as to form.
