Section 1. The Mayor and the Director of Public Safety, on behalf of the City of Pittsburgh, are hereby authorized to enter into an Agreement or Agreements with Hundred Public Safety Inc. DBA Performance Protocol for professional services to identify and implement solutions to further improve Pittsburgh Bureau of Police recruitment and retention efforts, at a cost not to exceed THIRTY-EIGHT THOUSAND, ONE HUNDRED SEVENTY-TWO DOLLARS (\$38,172.00) over one (1) year.
