Resolution amending Resolution Number 525 of 1990, effective May 24, 1990, entitled, “Authorizing the Mayor and the Director, Department of Public Works to execute a long-term agreement with the Allegheny County Sanitary Authority (ALCOSAN) and the Township of North Fayette to enlarge the area serviced by the Sanitary Authority to provide sewage treatment services for the above, located in the Township of North Fayette”, by authorizing the Mayor and the Director, Department of Public Works to execute an Amended Agreement with ALCOSAN and the Township of North Fayette (the “Township”) in a form substantially similar to the Agreement attached as “Attachment A”.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of the Department of Public Works are authorized to execute on behalf of the City of Pittsburgh (the “City”) the First Amendment to the Sewer Services Agreement which was entered into by and among the City of Pittsburgh, the Allegheny County Sanitary Authority (“ALCOSAN”), and the Township of North Fayette (the “Township”), effective March 11, 1991.

Section 2. The First Amendment shall be executed by the City together with ALCOSAN and the Township of North Fayette.

Section 3. The First Amendment amends the 1991 Agreement by increasing the allotted sewage capacity to the Township on terms as set forth in the Amended Agreement.

Section 4. There shall be no cost to the City arising from this Amendment to the original 1991 sewer services Agreement.
