Resolution authorizing the City's acceptance of a deed and/or deeds conveying all right, title, and interest, if any, in three parcels located in Council District 3 and the 17th Ward being identified as Block 3-B, Lot 100, Block 3-C, Lot 182, and Block 12-A, Lot 130, from the Urban **Redevelopment** Authority of Pittsburgh to the City of Pittsburgh at no cost to the City.

WHEREAS, the Urban Redevelopment Authority of Pittsburgh, the current owner of Block 3-B, Lot 100 (between South 6th and South 8th streets), Block 3-C, Lot 182 (between South 8th and South 9th streets), and Block 12-A, Lot 130 (between South 16th and South 17th streets) in the 17th Ward (collectively, the "Parcels"), has offered to donate the Parcels to the City of Pittsburgh for use public park and trail space.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. That execution of a deed and/or deeds by and between the Urban Redevelopment Authority of Pittsburgh and the City of Pittsburgh to convey the three parcels located in Council District 3 and the 17th Ward being identified as Block 3-B, Lot 100, Block 3-C, Lot 182, and Block 12-A, Lot 130, to the City of Pittsburgh at no cost, is hereby approved.

Section 2. That acceptance of the aforementioned deed and/or deeds by the City of Pittsburgh is hereby

approved.
