Resolution authorizing the Mayor and the Director of the Department of Public Works to enter into an Agreement, Agreements, and/or Amendments with the Pittsburgh Water and Sewer Authority (“PWSA”) for the purpose of Municipal Sewer Compliance at Volunteers Ballfield in the Carrick neighborhood, at a City cost not to exceed Four Hundred and Eighty-Six Thousand, Eight Hundred and Eight Dollars (\$486,808.00) over a period of one (1) year.

WHEREAS, the City and PWSA wish to regrade and rebuild Volunteers Ballfield to install stormwater management facilities in order to meet Municipal Sewer Compliance goals in the Carrick Neighborhood; and

WHEREAS, PWSA is overseeing design and construction of the stormwater management components, and has or will retain professional services for the same; and

WHEREAS, the City will participate and is willing to reimburse PWSA Four Hundred Eighty-Six Thousand, Eight Hundred and Eight Dollars (\$486,808.00).

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of the Department of Public Works are hereby authorized to enter into an Agreement, Agreements, and/or Amendments with PWSA for the purpose of Municipal Sewer Compliance at Volunteers Ballfield in the Carrick neighborhood, at a City cost not to exceed Four Hundred and Eighty-Six Thousand, Eight Hundred and Eight Dollars (\$486,808.00) over a period of one (1) year, chargeable and payable from JDE Capital Bond account number 4573480121.54207.00.

Section 2. The Agreement and Amendments thereto shall be approved by the City Solicitor as to form.
