Additionally, offsite childcare will be provided for those attending community events sponsored by the Mayor's Office of Neighborhood Services, and providing for payment of the cost thereof." By increasing the total amount not to exceed by Forty-Five Thousand Dollars (\$45,000.00) For a new total cost not to exceed Ninety Thousand Dollars (\$90,000.00), and extending the program for an additional year.

Resolution amending Resolution Number 655 of 2023, entitled "Resolution authorizing the Mayor and the Director of the Department of Human Resources and Civil Service to enter into a Professional Services Agreement(s) and/or Contracts with Pittsburgh Event Childcare for professional services in connection with onsite childcare being provided to City of Pittsburgh employees during the days that school is not in session. Additionally, offsite childcare will be provided for those attending community events sponsored by the Mayor's Office of Neighborhood Services, and providing for payment of the cost thereof." By increasing the total amount not to exceed by Forty-Five Thousand Dollars (\$45,000.00) For a new total cost not to exceed Ninety Thousand Dollars (\$90,000.00), and extending the program for an additional year.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of the Department of Human Resources and Civil Service, on behalf of the City of Pittsburgh, are hereby authorized to amend Resolution Number 655 of 2023 and enter into a Professional Services Agreement(s) and/or Contracts with Pittsburgh Event Childcare, with an amount not-to-exceed Ninety Thousand Dollars (\$90,000.00) over three years.

The City Controller shall encumber funds for the contract, subject to the amount of funds to be appropriated by

City Council in respective budget year from the following chart account:

\$8,625.00 from 11101.109000.53.53901.2023

\$36,375.00 from 11101.109000.53.53901.2024

\$45,000.00 from 11101.109000.53.53901.2025

Section 2. Said agreement or agreements and any amendment or amendments shall be approved by the City Solicitor as to form and substance.
