Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Resolution authorizing the Mayor and the City Solicitor, on behalf of the City of Pittsburgh, to enter into a professional services agreement with the law firm of Fisher Phillips LLP, in connection with issues involving labor disputes, at a cost not-to-exceed Sixty-Thousand Dollars and Zero Cents (\$60,000) over one (1) year.” is hereby amended as follows:

Section 1. Resolution authorizing the Mayor and the City Solicitor to enter into a Professional Services Agreement or agreements and amendments thereto, with Fisher Phillips LLP for legal services in connection

with labor disputes, by adding an additional One Hundred Fifty Thousand Dollars (\$150,000), for a new amount not to exceed Two Hundred Ten Thousand Dollars (\$210,000.00), and adding one additional year for a contract term of two (2) years charging to and payable from the following JD Edwards Accounts:
