Resolution amending Resolution No. 565 of 2024 which authorized thirty six (36) Open-End Professional Services Agreements with multiple vendors to provide professional services on an on-call basis as required related to various professional services as needed by the various Departments of the City of Pittsburgh, each Agreement being at an amount not-to-exceed seven hundred fifty thousand dollars (\$750,000) annually for a three year term, and providing for funding of the costs thereof, by authorizing fifty six (56) additional Open-End Professional Services Agreements with multiple vendors for same various professional services.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Resolution No. 565 of 2024, entitled “Resolution authorizing thirty-six (36) Open-End Professional Services Agreements with multiple vendors to provide professional services on an on-call basis as required related to various professional services as needed by the various Departments of the City of Pittsburgh, each Agreement being at an amount not-to-exceed seven hundred fifty thousand dollars (\$750,000) annually for a three-year term, and providing for funding of the costs thereof” is hereby amended as follows:

SECTION 1. The City of Pittsburgh, through the Office of Management & Budget, is hereby authorized to enter into ninety two (92) Open-End Professional Services Agreements with multiple vendors for three (3) year terms, in order to provide professional services on an on-call basis as required related to various professional

services as needed by the various Departments of the City of Pittsburgh.

SECTION 2. Because the agreements provide services on an as-needed basis, expenditures under these agreements will be identified when work orders are issued. If funding for any work order has not been previously appropriated, funding will be identified and appropriated through subsequent City Council action. Funding is available as appropriated when listed per project in the Operating and/or Capital Budget.

SECTION 3. No agreement will cost an amount greater than seven hundred fifty thousand dollars (\$750,000) per year. In no event will any estimated work order for a project issued under these agreements exceed one hundred thousand dollars (\$100,000) in value.
