Resolution authorizing the Mayor and the Director of Parks and Recreation to enter into a two-year sponsorship agreement with Clearview Federal Credit Union for the 2025 and 2026 Gingerbread House Display and Tree Lighting Ceremony at no cost to the City.

WHEREAS, each December, the City presents the Gingerbread House Display and Tree Lighting Ceremony at the City-Council Building; and

WHEREAS, Clearview Federal Credit Union desires to provide the City with financial sponsorship support for the Gingerbread House Display and Tree Lighting Ceremony; and the parties wish to enter into a Sponsorship Agreement for the years 2025 and 2026; and

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of Parks and Recreation are authorized to enter into a sponsorship agreement with Clearview Federal Credit Union for the 2025 and 2026 Gingerbread House Display and Tree Lighting Ceremony over two (2) years. The schedule of sponsorship fee payments due from Clearview Federal Credit Union is as follows:

2025: Eight Thousand Dollars (\$8,000.00)
2026: Eight Thousand Dollars (\$8,000.00)

Section 2. All monies from the aforementioned sponsors will be deposited into the following JDE account: 5000731400.48106.00.

Section 3. The authorized sponsorship agreement may also include a Right of First Refusal for the sponsor to continue its sponsorship status for two additional years in a similar capacity, subject to further negotiations by the parties and further approval by City Council.

Section 4. Said Agreement shall be in a form approved by the City Solicitor.
