Resolution amending Resolution 1 of 2022, which amended Resolution 322 of 2018, which authorized the Mayor and the Director of the Department of Human Resources and Civil Service to enter into an Agreement with Integrated Health 21, LLC for services relating to the administration and management of a wellness portal, by extending the term for six months, adding Eighty Thousand Five Hundred Forty dollars (80,540.00), for a not to exceed amount of One Million Forty-Eight Thousand Five Hundred and Twenty Dollars (\$1,048,520.00).

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of the Department of Human Resources and Civil Service, on behalf of the City of Pittsburgh, are hereby authorized to enter into an Agreement with Integrated Health 21, LLC for services relating to the administration and management of a wellness portal for the City of Pittsburgh's employees, by amending Resolution 1 of 2022 which amended Resolution 322 of 2018 by adding Eighty Thousand Five Hundred Forty dollars (80,540.00), for a sum not to exceed One Million Forty-Eight Thousand Five Hundred and Twenty Dollars (\$1,048,520.00) over six (6) years and six (6) months and for the payment of the costs thereof.

Funds shall be allocated as follows, subject to annual appropriation by City Council in future budget years:
