Resolution authorizing the Mayor and the Director of the Department of City Planning, to enter into an Agreement or Agreements between the City of Pittsburgh and Bloomfield-Garfield Corporation, for the installation and maintenance of a mural at Leslie Recreation Center, at no cost to the City

**WHEREAS**, Lawrenceville United, Bloomfield Garfield Corporation, and BOOM Concepts have proposed the creation of a mural on the exterior wall of Leslie Recreation Center Pool building, on property owned by the City of Pittsburgh; and

**WHEREAS**, the installation of the mural is supported by the Department of Public Works; and

**WHEREAS**, the Public Realm Division of the Department of City Planning administers the implementation of community-led public art projects on City property; and

**WHEREAS**, the City of Pittsburgh intends to grant Bloomfield-Garfield Corporation license to install and maintain the artwork at this location, with no cost to the City of Pittsburgh and without transfer of ownership to the City of Pittsburgh.

**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** Authorizing the Mayor and the Director of the Department of City Planning, to enter into an

Agreement or Agreements between the City of Pittsburgh and Bloomfield-Garfield Corporation, for the installation and maintenance of a mural at Leslie Recreation Center.
