Resolution authorizing the Mayor and Director of Public Safety to enter into a License Agreement or Agreements between the City of Pittsburgh and Plaza at Grandview Owner's Association at a cost not to exceed ONE HUNDRED FIVE THOUSAND SIX HUNDRED DOLLARS (\$105,600) over five years.

WHEREAS, the Plaza at Grandview Owner's Association ("Owner") owns a condominium building located at 111 Grandview Avenue, Pittsburgh, PA 15211; and

WHEREAS, the City seeks to maintain previously installed cameras on rooftops within the City of Pittsburgh for the purpose of providing enhanced security to its citizens; and

WHEREAS, Owner and City previously agreed to allow the City to install, operate and/or maintain, at the City's sole cost and expense, video cameras and related equipment on the Owner's building rooftop at 111 Grandview Avenue for security and other public safety purposes, pursuant to a license agreement that expires December 31, 2025; and

WHEREAS, Owner and City desire to continue said arrangement for an additional five-year term.

**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** The Mayor and the Director of Public Safety are hereby authorized to enter on behalf of the City

of Pittsburgh into a License Agreement or Agreements with the Plaza at Grandview Owner's Association for the continued installation, operation, and/or maintenance of video cameras and related equipment on the building rooftop at 111 Grandview Avenue for security and other public safety purposes at a total cost not to exceed ONE HUNDRED FIVE THOUSAND SIX HUNDRED DOLLARS (\$105,600) over five years.

**Section 2.** Payments due under said Agreement(s) shall be chargeable to and payable from the following JDE account codes in their respective budget years, subject to City Council appropriations:
